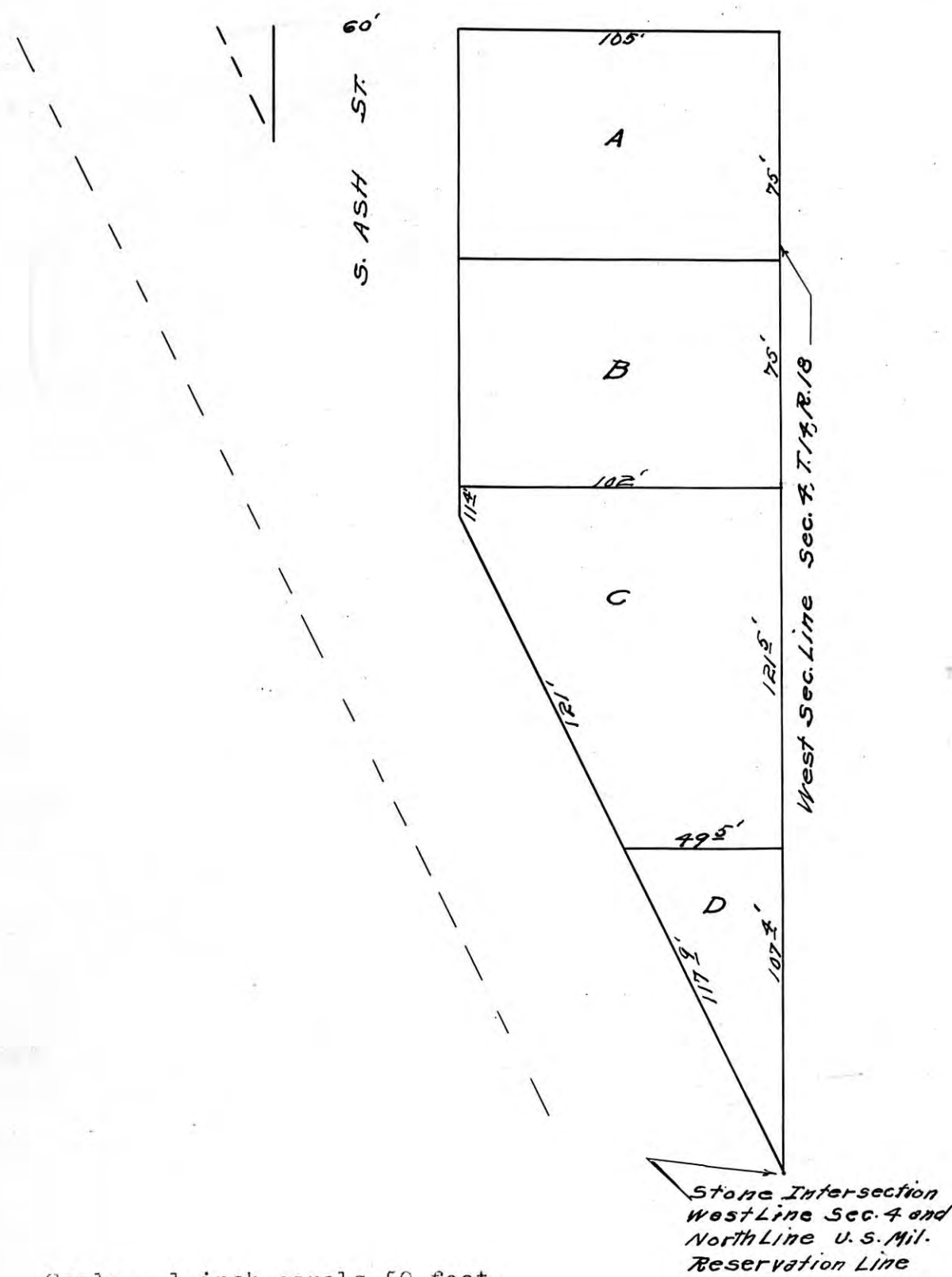


E. H. BENOIT'S SUBDIVISION OF LOT 19 AND 20,
