# CEDARCREST FIRST ADDITION

TO THE CITY OF HAYS, KANSAS

**LEGAL DESCRIPTION:**

A tract of land in the Northeast one-quarter of Section 34, Township 13 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas, and further described as follows:

Beginning at a point on the West line of the Northeast quarter of Section 34, 737.52 feet North of the Southwest corner of said Northeast one-quarter; thence East with an external angle of 89 degrees 36 minutes 33 seconds, 179.55 feet; thence South parallel to the East line of said Northeast one-quarter, 337.70 feet; thence left on a curve of 70 foot radius with an internal angle of 89 degrees 40 minutes 30 seconds, an arc distance of 109.50 feet; thence Easterly parallel to the North line of Twenty-Second Street, 230 feet; thence Northerly with an internal angle of 90 degrees 18 minutes 27 seconds and parallel to the East line of said Northeast one-quarter, 556.86 feet; thence Northeasterly and right on a curve of 270 foot radius with an internal angle of 37 degrees 30 minutes, an arc distance of 176.72 feet; thence Northeasterly on a tangent to said curve, 129.08 feet; thence Westerly with an internal angle of 52 degrees 08 minutes and parallel to the South line of said Northeast one-quarter, 613.33 feet to the West line of said Northeast one-quarter; thence South with an internal angle of 90 degrees 27 minutes along the West line of said Northeast one-quarter, 413.58 feet to the point of beginning.

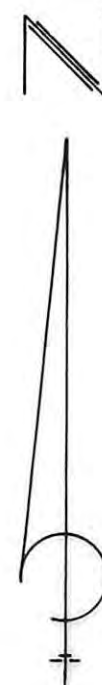

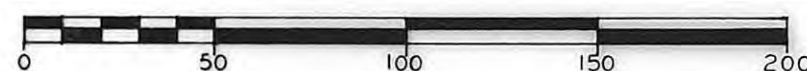
