LEGAL DESCRIPTION:

A tract of land in the Northwest Quarter (NW/4) of Section Three (3), in Township Fourteen (14) South, Range Eighteen (18) West of the Sixth (6th) Principal Meridian, described as follows:

Beginning at a point 1,420 feet East and 33 feet South of the Northwest corner of Section 3; thence South parallel to the West line of said Section 3, a distance of 435.6 feet; thence East, parallel to the North line of said Section 3, a distance of 300 feet; thence North, parallel to the West line of said Section 3, a distance of 435.6 feet to the South line of Thirteenth Street in the City of Hays, Kansas, thence West, along the South line of Thirteenth Street, 300 feet to the point of beginning. (Contains 3.0 acres.)

STREETS, ALLEYS, AND EASEMENTS:

Streets, alleys, and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing and maintaining all public and private utilities now or hereafter.

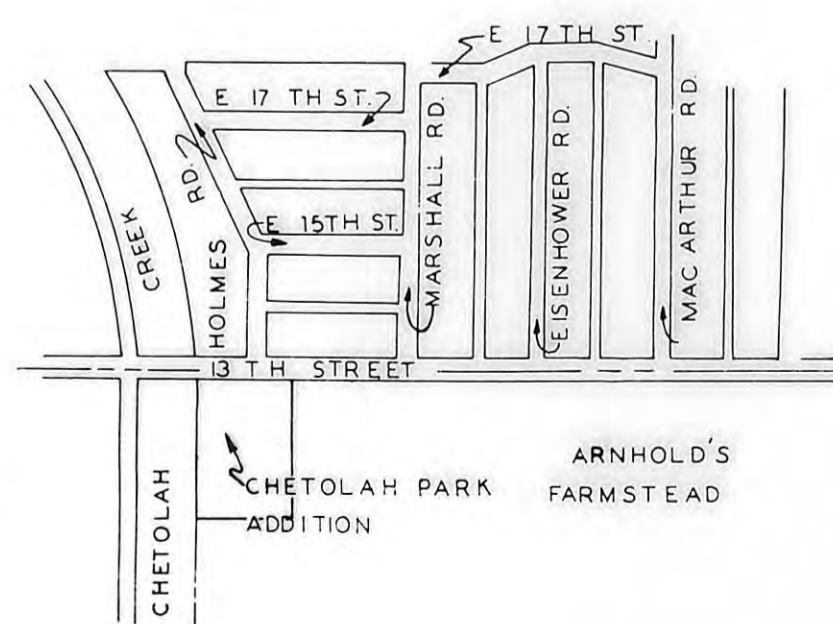
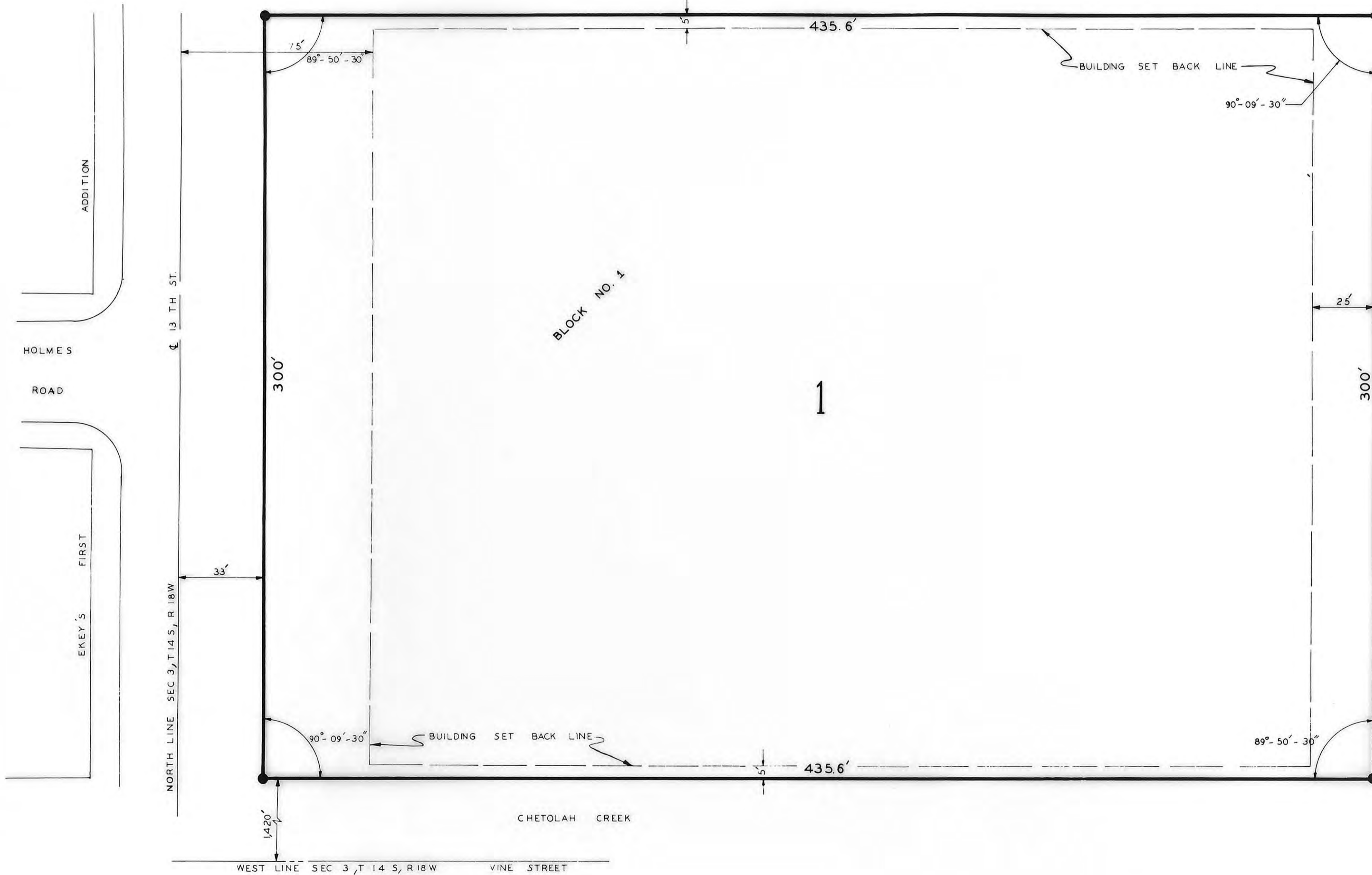
