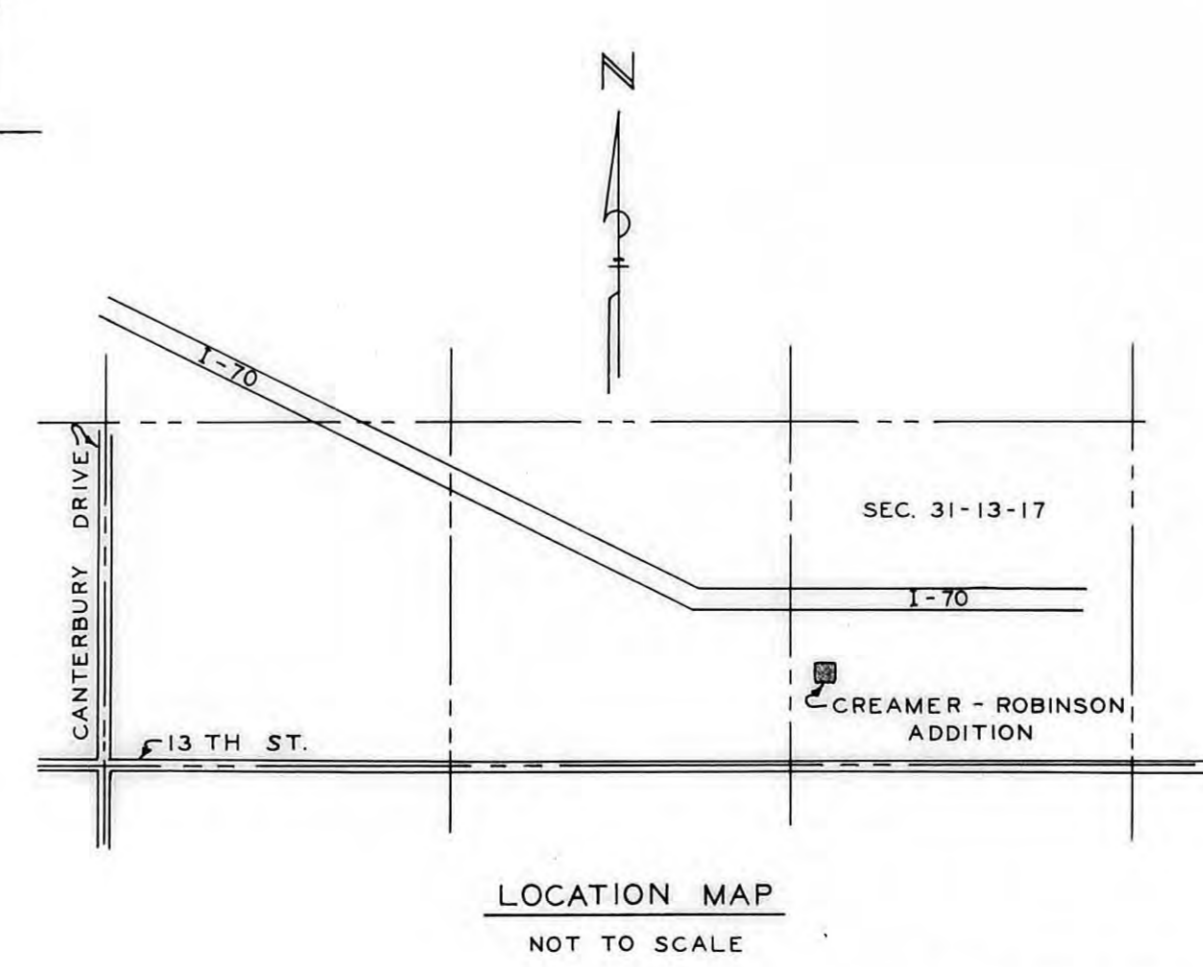
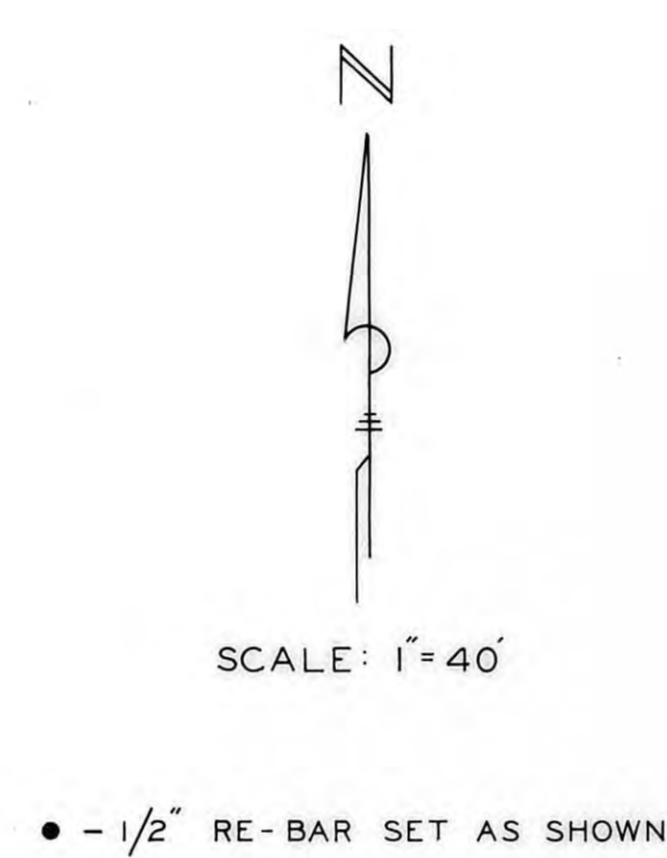
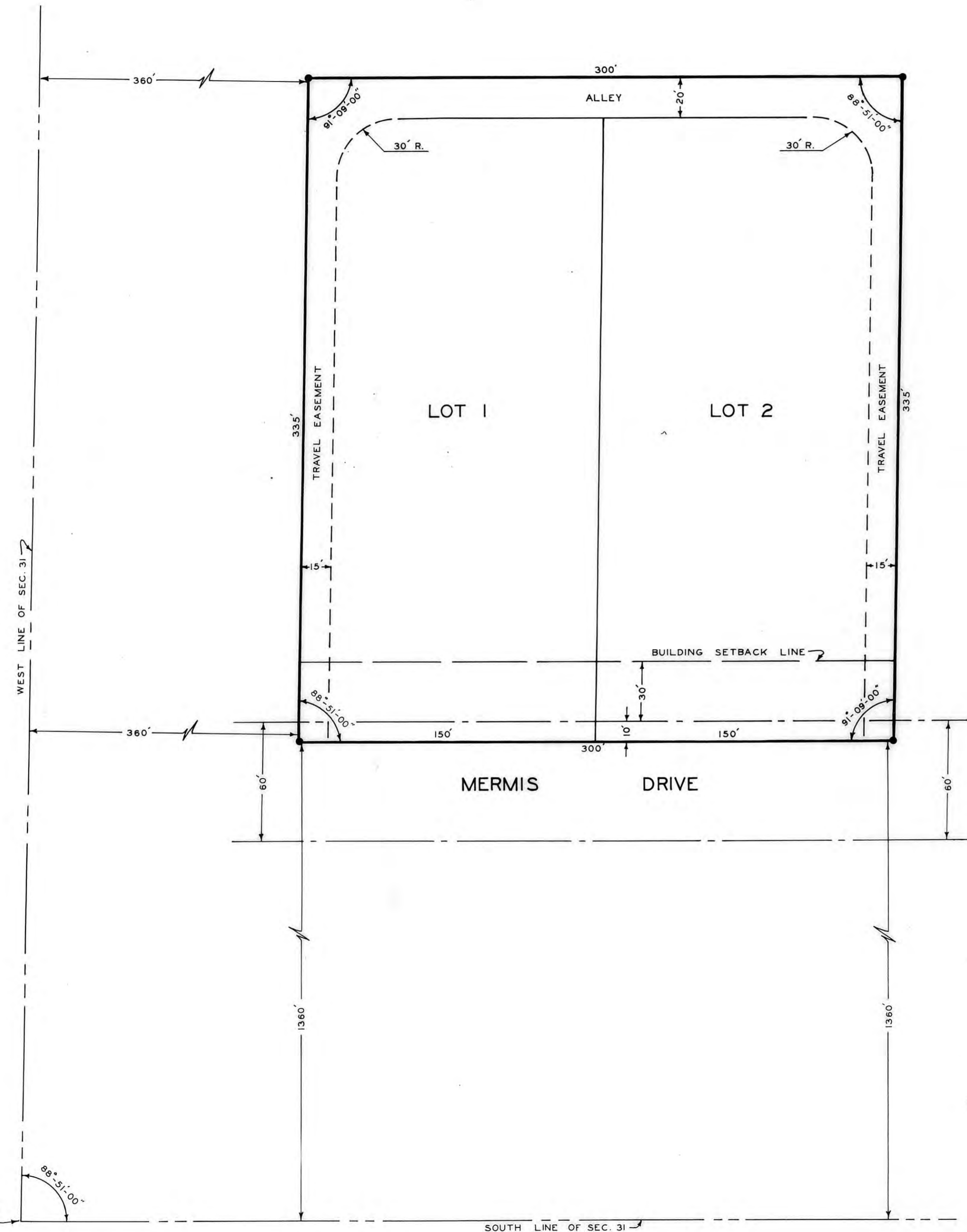


CREAMER, ROBINSON ADDITION

LEGAL DESCRIPTION:

A tract of land situated in the Southwest Quarter (SW/4) of Section Thirty-one (31), Township Thirteen (13) South, Range (17) West of the Sixth Principal Meridian, described as follows, to-wit:

Beginning at a point 360 feet East and 1,360 feet North of the Southwest corner of the Southwest Quarter (SW/4) of Section 31; thence East, parallel to the South line of said Section 31, a distance of 300 feet; thence North, parallel to the West line of said Section 31, a distance of 335 feet; thence West, parallel to the South line of said Section 31, a distance of 300 feet; thence South, parallel to the West line of said Section 31, a distance of 335 feet to the point of beginning. Tract contains 2.307 acres.

STREET, ALLEYS, AND EASEMENTS:

Street, alleys, and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing, and maintaining all public and private utilities now or hereafter.

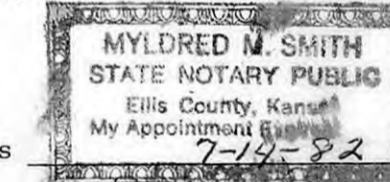

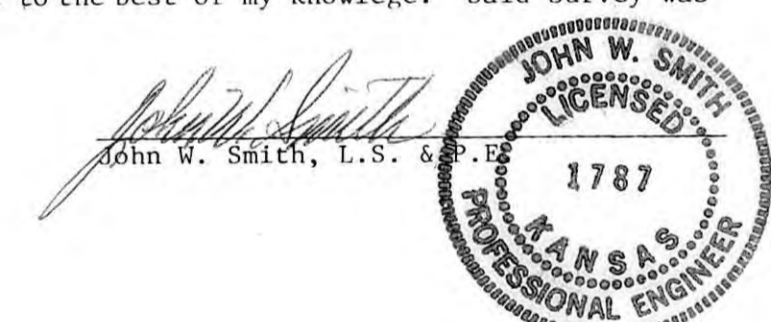
