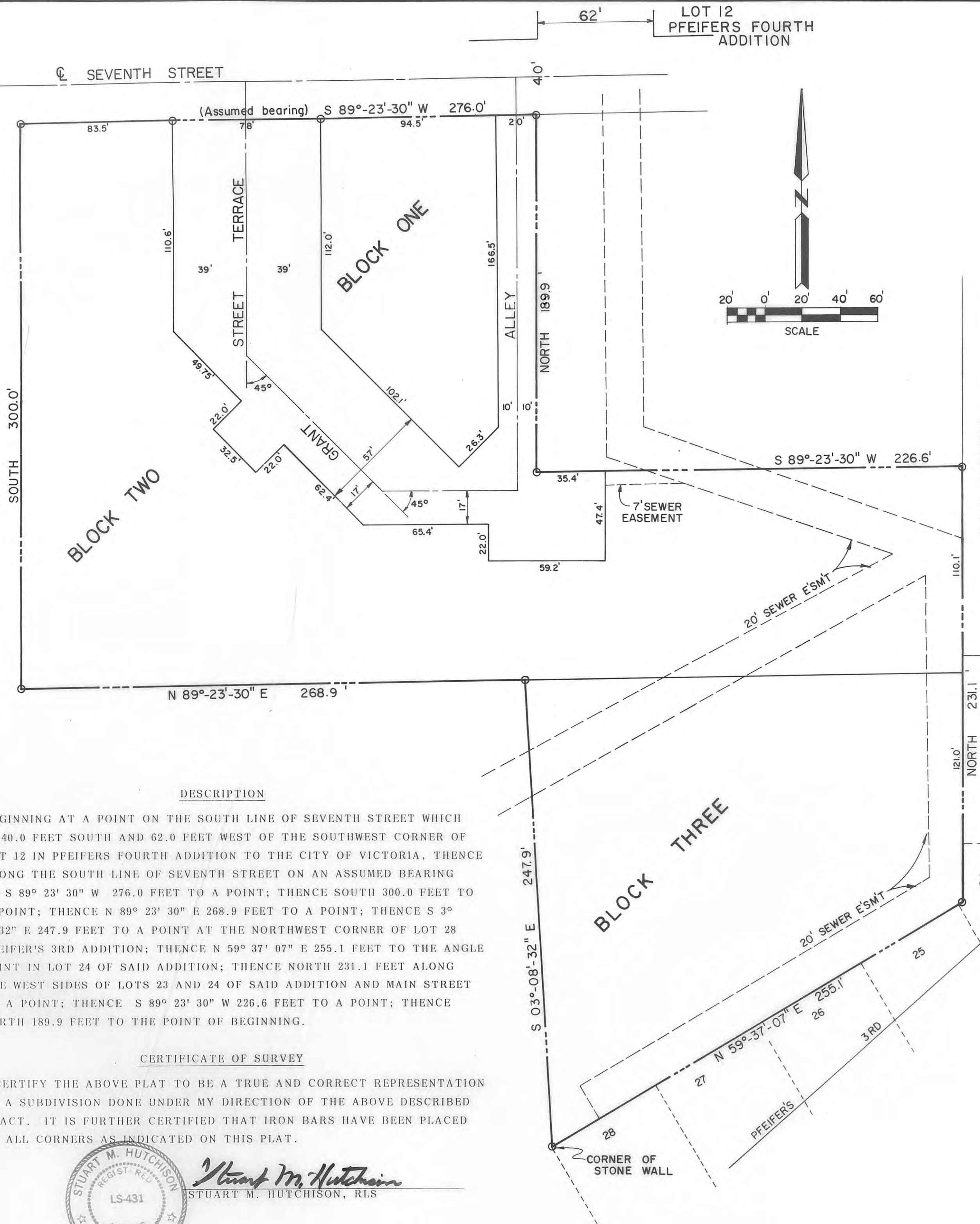


THE ELMS SUBDIVISION CITY OF VICTORIA, KANSAS

DESCRIPTION

BEGINNING AT A POINT ON THE SOUTH LINE OF SEVENTH STREET WHICH IS 40.0 FEET SOUTH AND 62.0 FEET WEST OF THE SOUTHWEST CORNER OF LOT 12 IN PFEIFERS FOURTH ADDITION TO THE CITY OF VICTORIA, THENCE ALONG THE SOUTH LINE OF SEVENTH STREET ON AN ASSUMED BEARING OF S 89° 23' 30" W 276.0 FEET TO A POINT; THENCE SOUTH 300.0 FEET TO A POINT; THENCE N 89° 23' 30" E 268.9 FEET TO A POINT; THENCE S 3° 8' 32" E 247.9 FEET TO A POINT AT THE NORTHWEST CORNER OF LOT 28 PFEIFER'S 3RD ADDITION; THENCE N 59° 37' 07" E 255.1 FEET TO THE ANGLE POINT IN LOT 24 OF SAID ADDITION; THENCE NORTH 231.1 FEET ALONG THE WEST SIDES OF LOTS 23 AND 24 OF SAID ADDITION AND MAIN STREET TO A POINT; THENCE S 89° 23' 30" W 226.6 FEET TO A POINT; THENCE NORTH 189.9 FEET TO THE POINT OF BEGINNING.
