

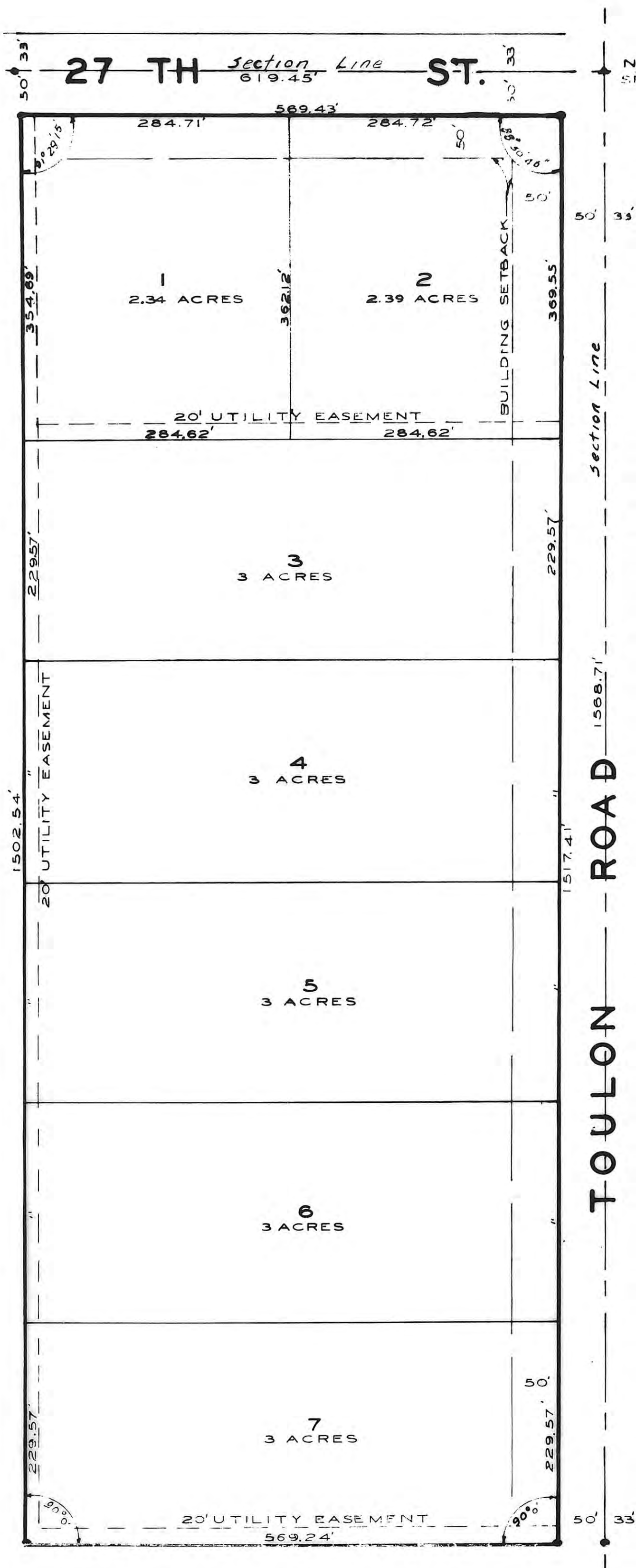

LEGAL DESCRIPTION:

Subdivision of a part of the Northeast Quarter of Section 31, Township 13 South, Range 17 West, Ellis County, Kansas, more fully described as follows:

Beginning at the marker marking the Northeast corner of the above Section 31; thence west along the north line of said Section 31, 619.45 feet; thence south, parallel with the east line of said Section 31, a distance of 1552.56 feet; thence east, at an angle of 90° 619.24 feet to the east line of said Section 31; thence north along east line of said Section 31, a distance of 1568.71 feet to the point of beginning.
