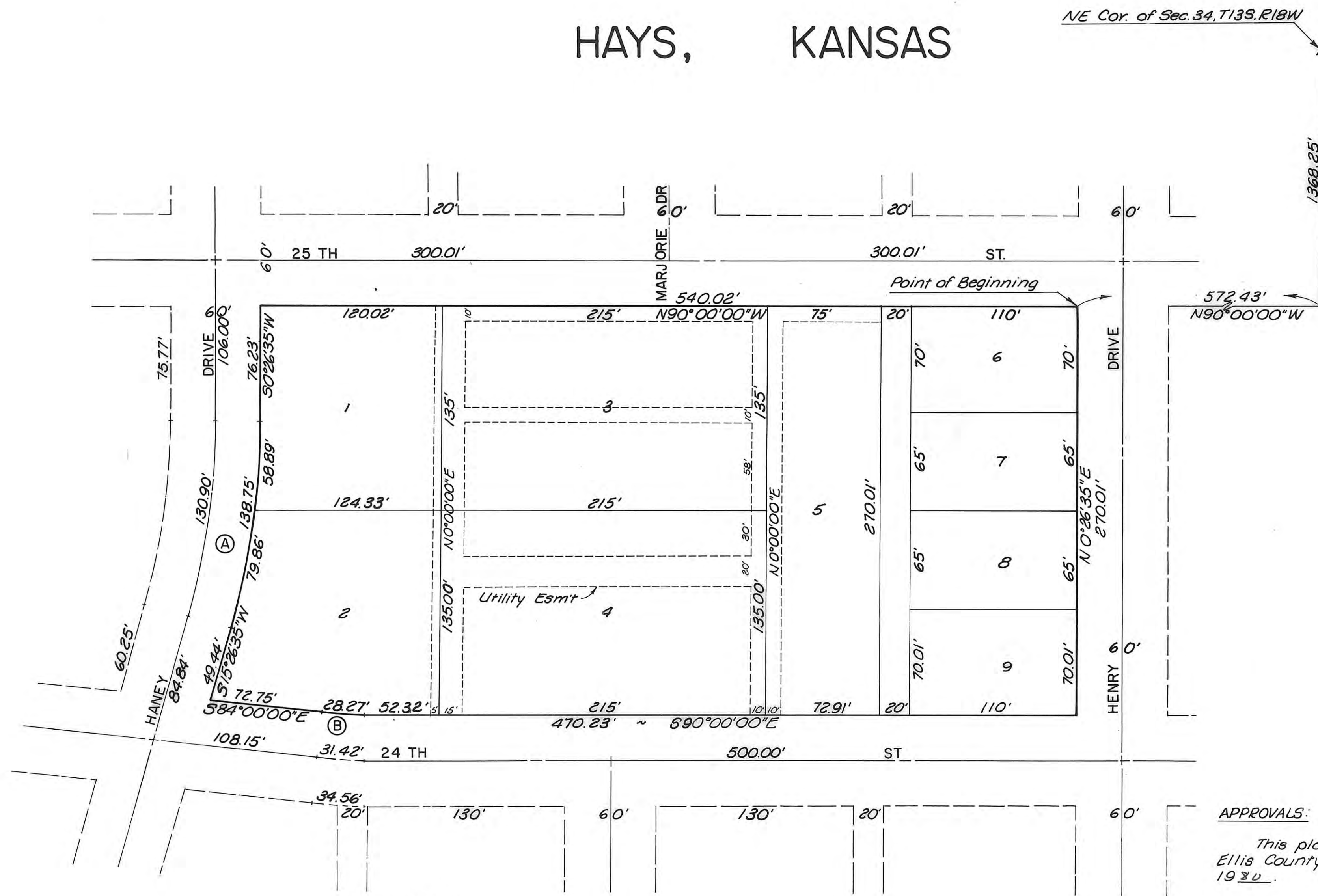
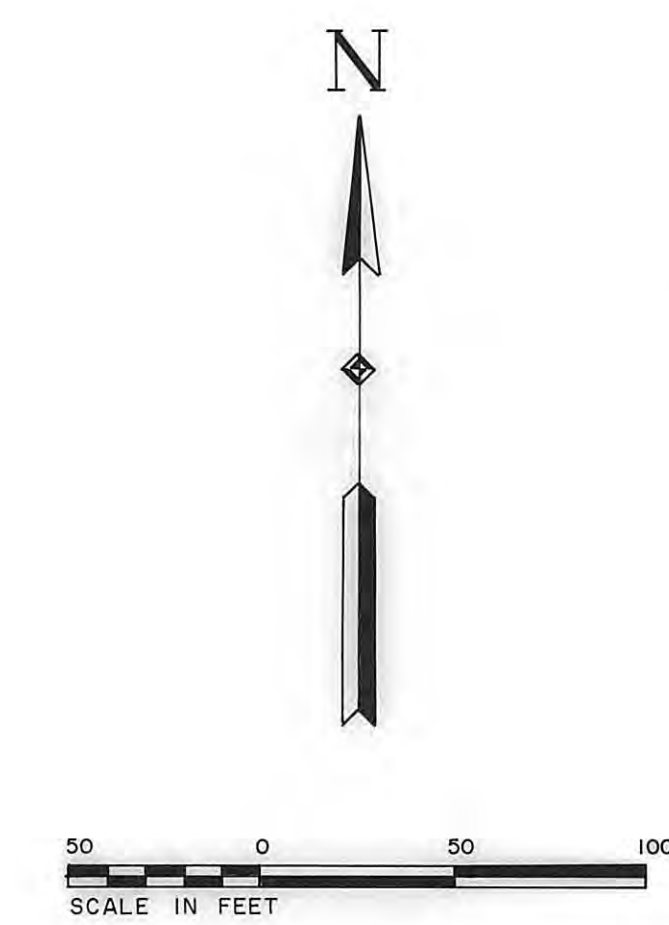


REPLAT OF BLOCK 6 OF GOLDEN BELT FOURTH ADDITION HAYS, KANSAS

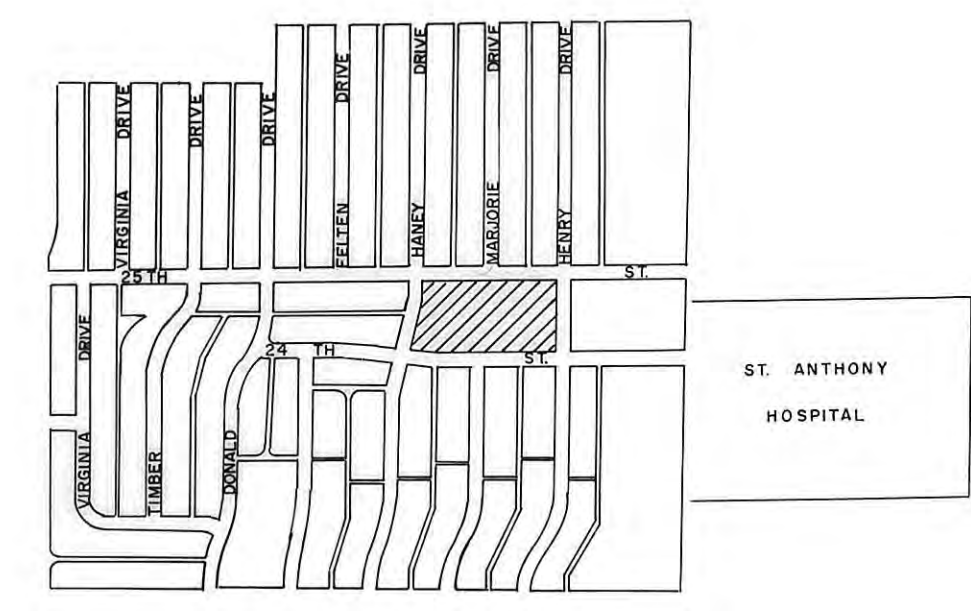
NE Cor. of Sec. 34, T13S, R18W

LEGAL DESCRIPTION OF BLOCK 6 OF GOLDEN BELT FOURTH ADDITION
 A Tract of land in the Northeast Quarter (NE 1/4) of Section 34, Township 13 South, Range 18 West of the Sixth Principal Meridian in Ellis County Kansas, and more particularly described as follows:
 Commencing at the Northeast Corner of Section 34, Township 13 South, Range 18 West; THENCE on an assumed bearing of 50°21'15"W, along the East line of said Section, a distance of 1368.25 feet; THENCE N90°00'00"W, a distance of 572.43 feet to the point of beginning; THENCE continuing on the last described course a distance of 540.02 feet; THENCE 50°26'35"W a distance of 76.23 feet; THENCE on a curve to the right having a radius of 530.00 feet, an arc distance of 138.75 feet; THENCE S15°26'35"W a distance of 49.44 feet; THENCE S84°00'00"E a distance of 72.75 feet; THENCE on a curve to the left having a radius of 270.00 feet, an arc distance of 28.27 feet; THENCE S90°00'00"E, a distance of 470.23 feet; THENCE N0°26'35"E, a distance of 270.01 feet to the point of beginning. Said tract contains 3.390 acres, more or less.
