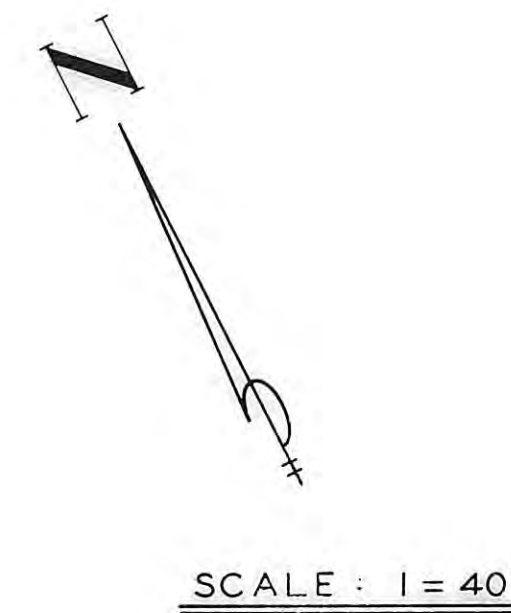
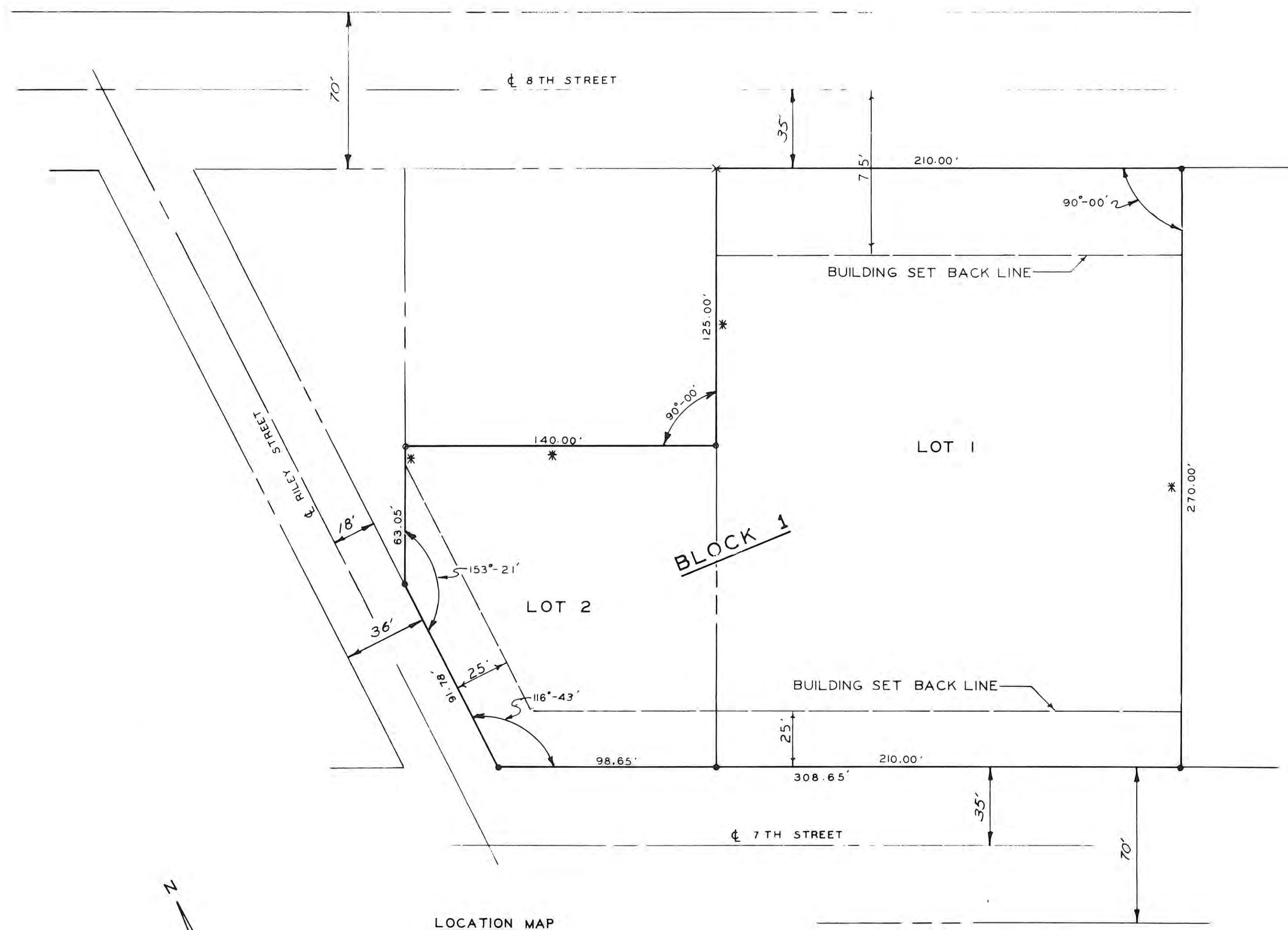
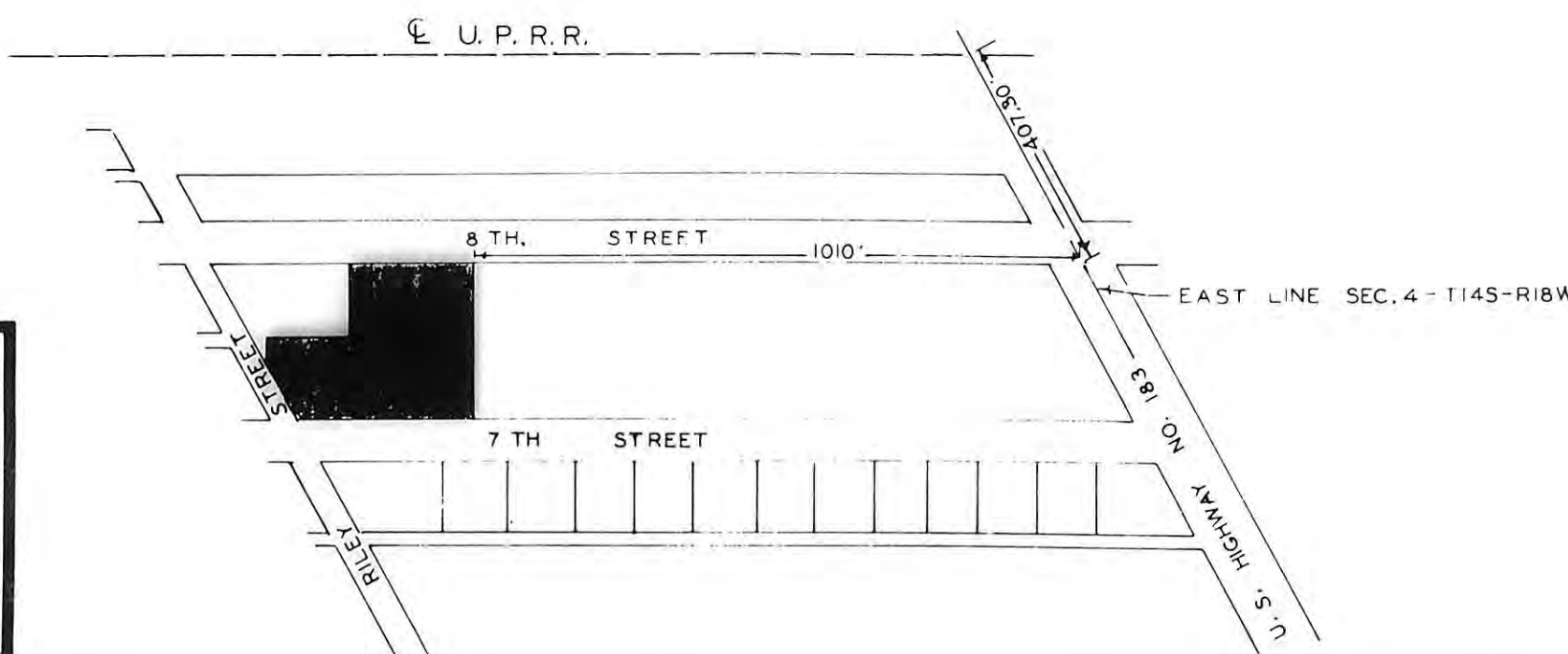
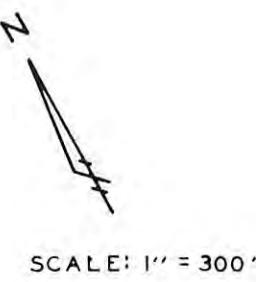


GORDON'S ADDITION

LEGAL DESCRIPTION:

A tract of land in the Northeast one-quarter of Section 4, Township 14 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas and further described as follows:

Beginning at a point on the South line of 8th Street 1,010 feet North 62 degrees 14 minutes West of the intersection of the East line of Section 4, said intersection being 407.30 feet South of the center of the Main Line of the Union Pacific Railroad; thence Southwesterly perpendicular to the South line of 8th Street 270.00 feet; thence Northwesterly 308.65 feet along the North line of 7th Street; thence North along the East line of Riley Street 91.78 feet; thence Northeasterly perpendicular to the South line of 8th Street 63.05 feet; thence Southeasterly parallel to the South line of 8th Street 140.00 feet; thence Northeasterly perpendicular to the South line of 8th Street 125.00 feet; thence Southeasterly along the South line of 8th Street 210.00 feet to the point of beginning. Tract contains 1.728 acres more or less.

STREETS, ALLEYS, AND EASEMENTS:

Streets, alleys, and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing, and maintaining all public and private utilities now or hereafter.
