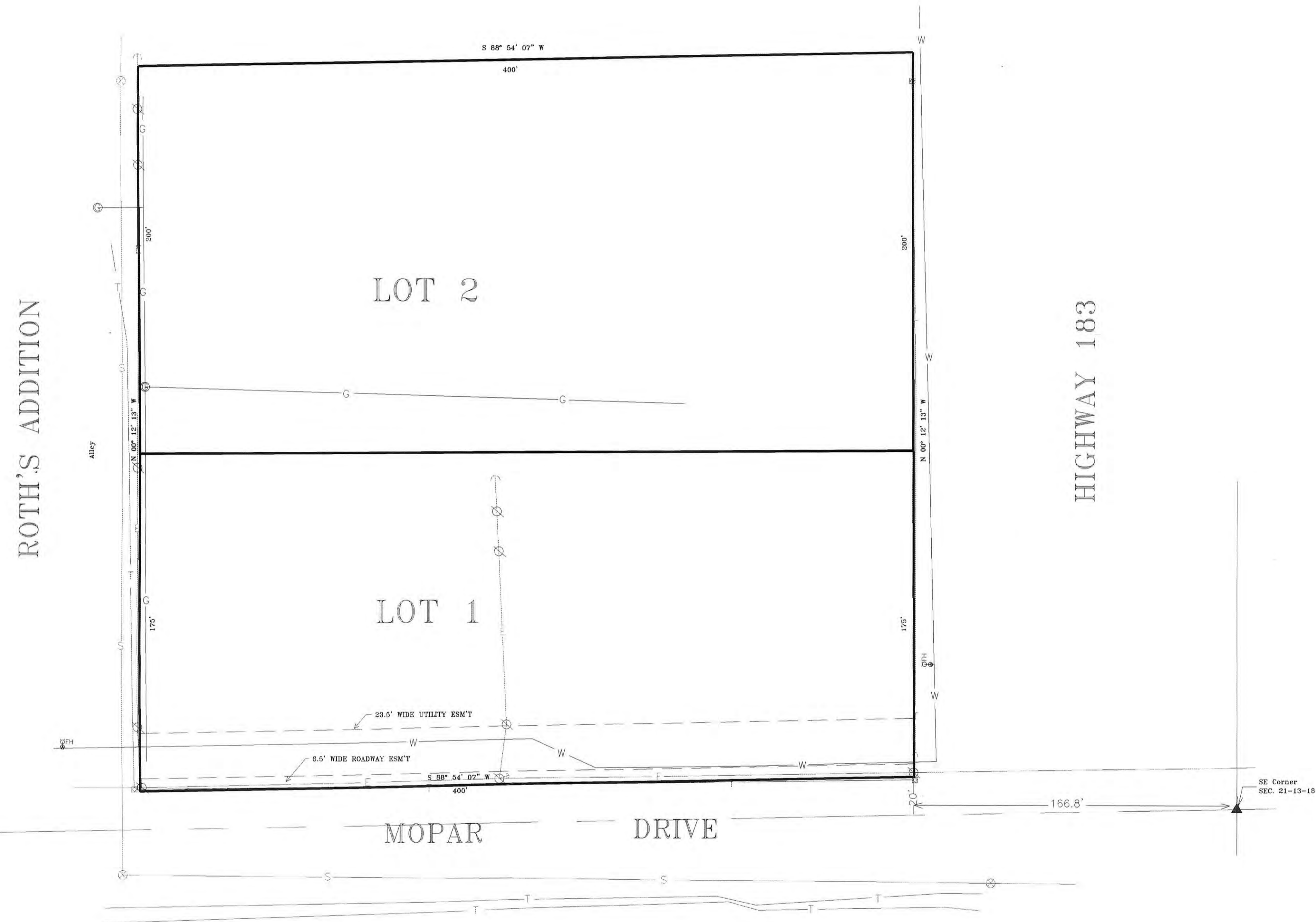


PLAT OF RALPH GOTTSCHALK'S ADDITION Hays, Kansas

ROTH'S ADDITION

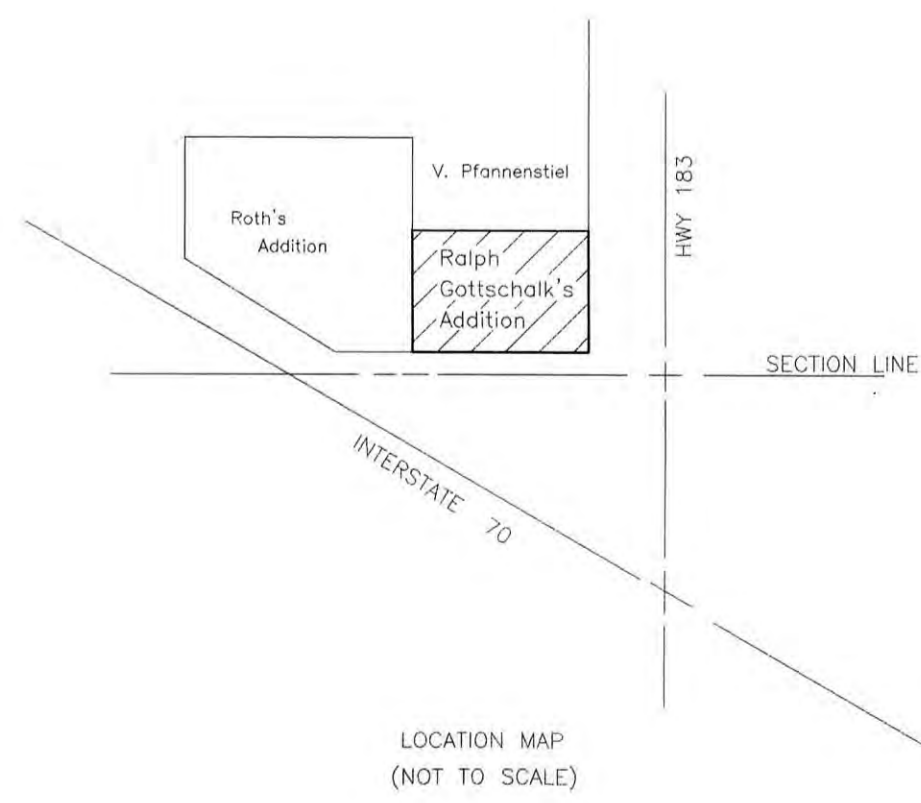

LEGAL DESCRIPTION:

A tract of land situated on a portion of the Southeast Quarter of Section Twenty-one (SE/4 Sec21), Township Thirteen (13) South, Range Eighteen (18) West of the Sixth Principal Meridian, City of Hays, Ellis County, Kansas, more particularly described as follows, to wit: Commencing at the Southeast corner of Section 21; Thence West along the South line of said Section 21 a distance of 166.8 feet; Thence North along the West right of way line of Highway 183 a distance of 20 feet to the POINT OF BEGINNING; Thence North along the West right of way line of Highway 183 a distance of 375 feet; Thence West parallel with the South line of Section 21 a distance of 400 feet; Thence South parallel with the West right of way line of Highway 183 a distance of 375 feet; Thence East parallel with the South line of said Section 21 a distance of 400 feet to the POINT OF BEGINNING.

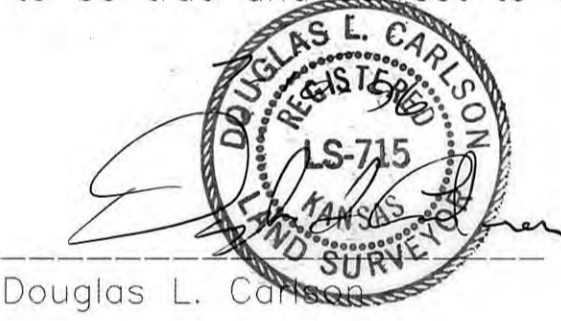
