

HAYS CITY SUBURBAN ESTATES

ELLIS COUNTY, KANSAS

LEGAL DESCRIPTION:

A tract of land in the Southeast One-Quarter of Section 1, Township 14 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas, more fully described as follows:

Beginning at a point on the East line of Section 1, Township 14 South, Range 18 West, said point being 260 feet North of the Southeast corner of said Section 1; thence North, along the East line of said Section 1, a distance of 895.7 feet; thence West, with an internal angle of 89 degrees 23 minutes, 2641.3 feet to the West line of the Southeast One-Quarter of said Section 1; thence South, along the West line of the Southeast One-Quarter 1,153.3 feet to the South line of said Section 1; thence East, along the South line of said Section 1, a distance of 2,011 feet; thence North, parallel to the East line of said Section 1, a distance of 260 feet; thence East, parallel to the South line of said Section 1, a distance of 630 feet to the point of beginning. (Tract contains 66.24 Acres, more or less).

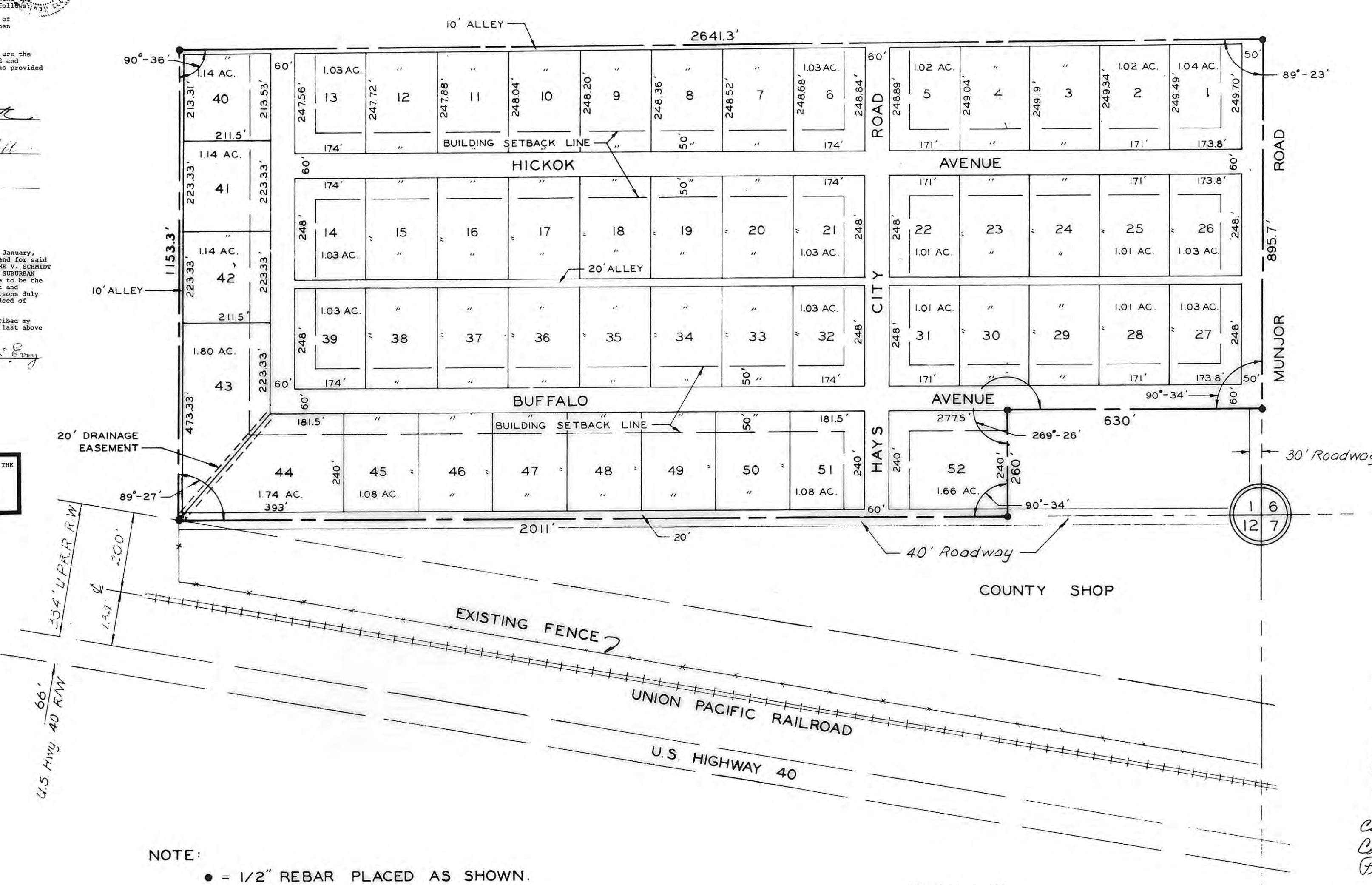
