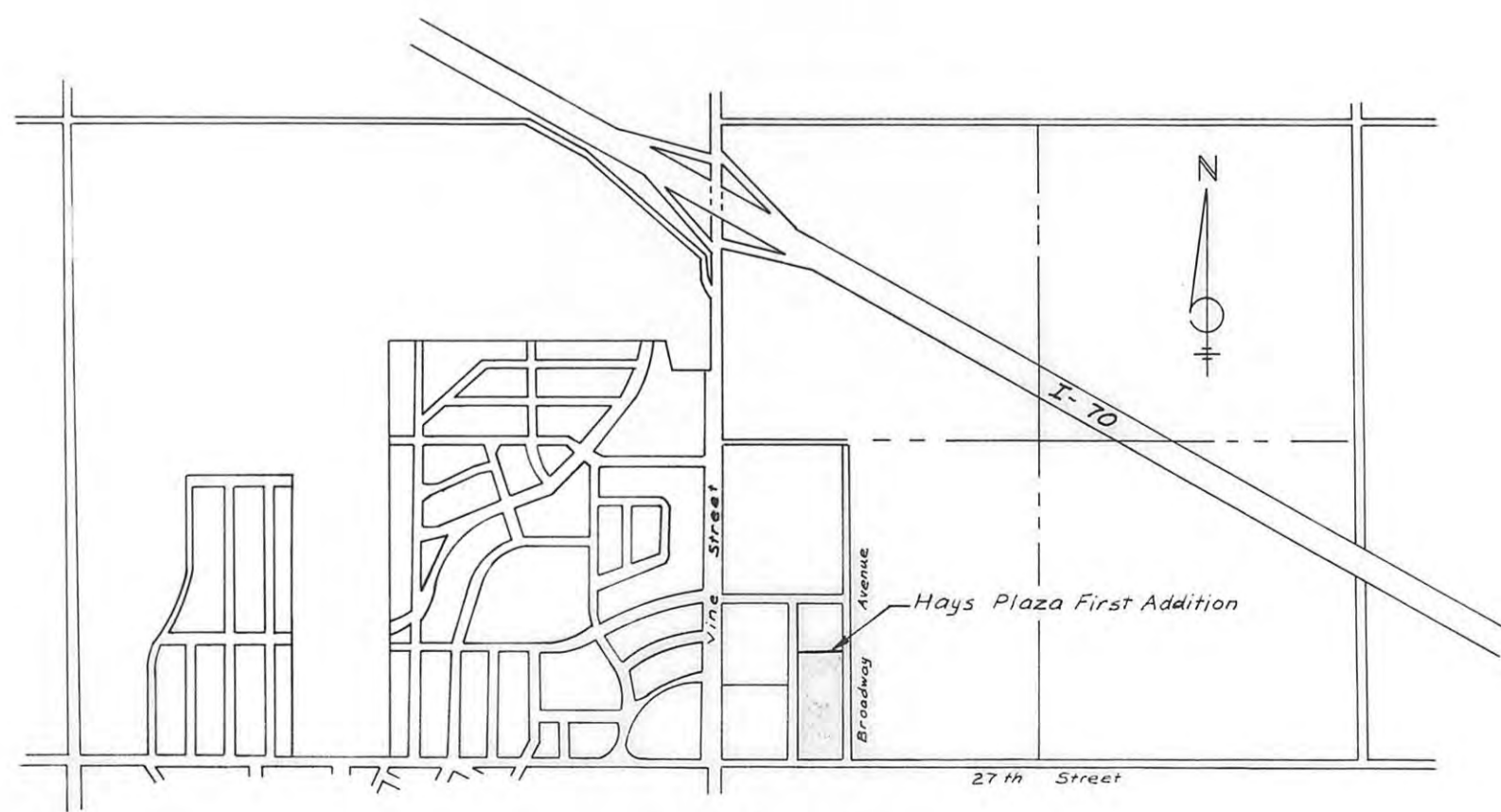
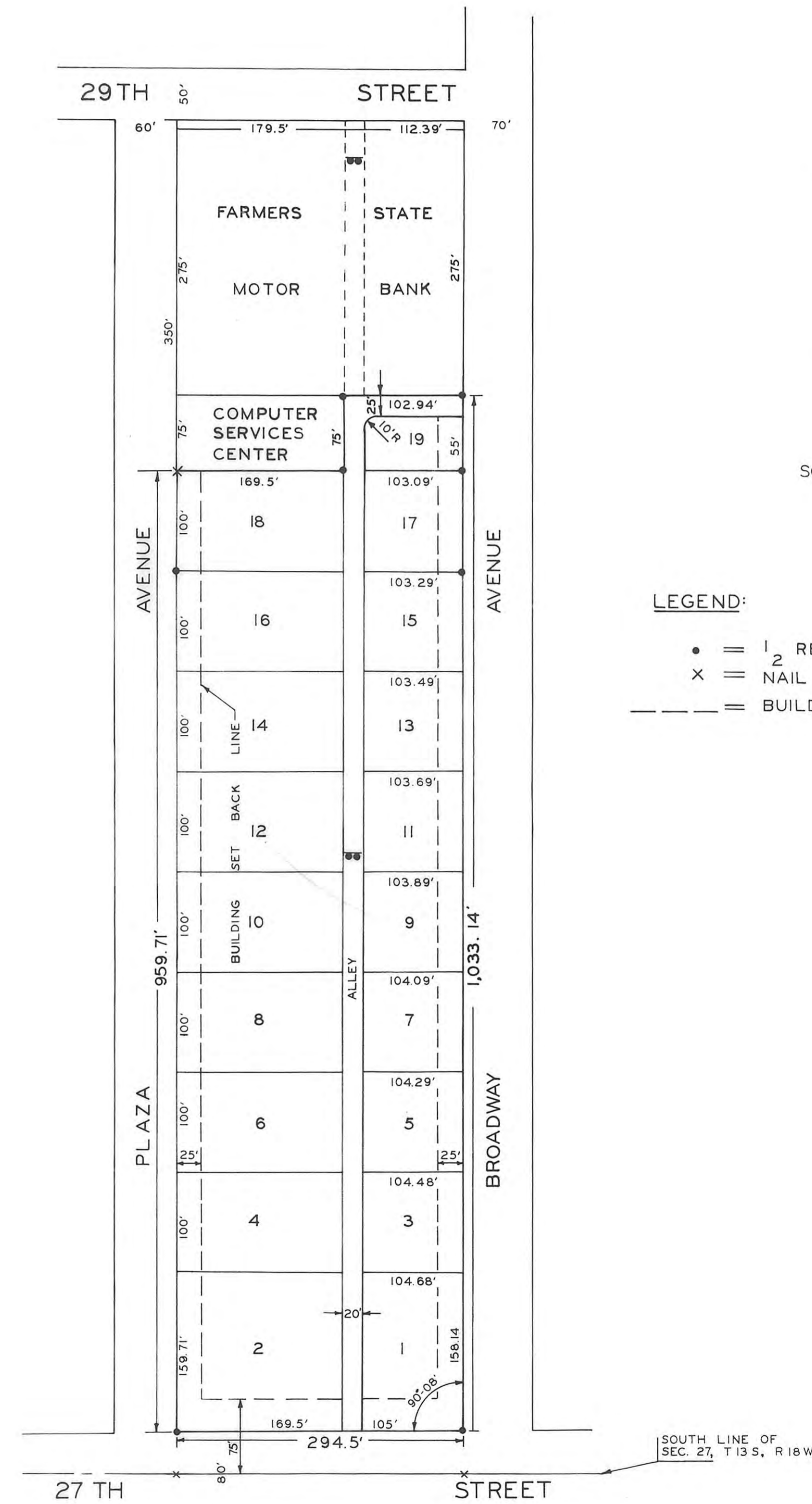


REPLAT OF A PORTION OF HAYS PLAZA FIRST ADDITION CITY OF HAYS, KANSAS

LEGAL DESCRIPTION:

A replat of a tract of land in Hays Plaza First Addition to the City of Hays, Kansas, further described as follows: Beginning at a point on the East Right-of-Way Line of Plaza Avenue, 350 feet South of the intersection of the South Right-of-Way Line of 29th Street and the East Right-of-Way Line of Plaza Avenue being the point of beginning; thence South, along the East Right-of-Way Line of Plaza Avenue, a distance of 959.706 feet; thence East, along the North Right-of-Way Line of 27th Street, a distance of 294.5 feet, to the West Line of Broadway Avenue; thence North along the West Line of Broadway Avenue, a distance of 1,033.14 feet; thence West, parallel to the South Line of 29th Street, a distance of 102.94 feet; thence South, parallel to the East Line of Plaza Avenue, a distance of 75 feet; thence West, parallel to the South line of 29th Street, a distance of 169.5 feet to the point of beginning. (Tract contains 6.644 acres.)

STREET, ALLEY AND EASEMENTS:

Street, alley and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing and maintaining all public and private utilities now or hereafter.
