

REPLAT OF LOT 2 OF BLOCK 8 HILLCREST 5TH ADDITION HAYS, KANSAS

LEGAL DESCRIPTION
 A tract of land in the Southwest Quarter (SW 1/4) of Section 28, Township 13 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas, and more particularly described as follows:
 Commencing at the Southwest corner of the Southwest Quarter (SW 1/4) of said Section 28; THENCE on an assumed bearing of N 1° 06' 45" E along the west line of said Southwest Quarter, a distance of 729.42 feet; THENCE S 89° 45' 15" E, a distance of 40.00 feet to the point of beginning; THENCE N 1° 06' 45" E, a distance of 485.00 feet; THENCE S 89° 52' 55" E, a distance of 264.14 feet; THENCE on a curve to the right having a radius of 270.00 feet, an arc distance of 154.06 feet; THENCE tangent to said curve S 57° 11' 21" E, a distance of 225.75 feet; THENCE on a curve to the left having a radius of 590.00 feet, the initial tangent of which has a bearing of S 29° 53' 54" W, an arc distance of 305.19 feet, the terminal tangent of which has a bearing of S 0° 15' 39" W, THENCE S 1° 04' 45" W, a distance of 30.00 feet; THENCE N 89° 44' 10" W, a distance of 529.96 feet to the point of beginning. Said tract contains 5.832 acres, more or less.

STREETS, EASEMENTS AND PUBLIC PARKS
 Streets, boulevards, drives, alleys, and pedestrian walkways as shown on this plat and not heretofore dedicated to and for public use are hereby so dedicated.
 Easements are hereby dedicated for public use, as utility easement right-of-way, which are shown as lying between the dashed lines in widths indicated and as set forth on this plat, and said easements may be employed for the purpose of installing, repairing, and maintaining gas lines, electric lines, telephone lines, and all other forms and types of public utilities, new or hereafter used, by the public over, under and along the strips marked "Utility Esm't."

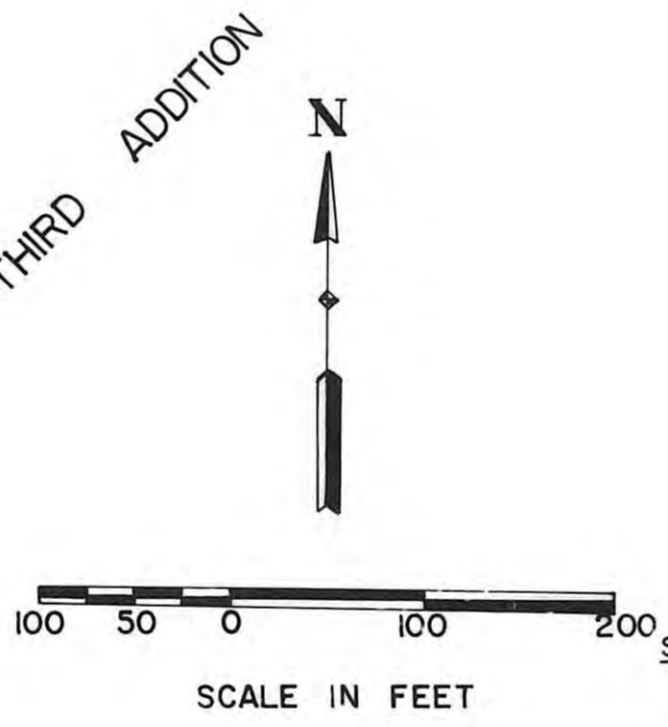
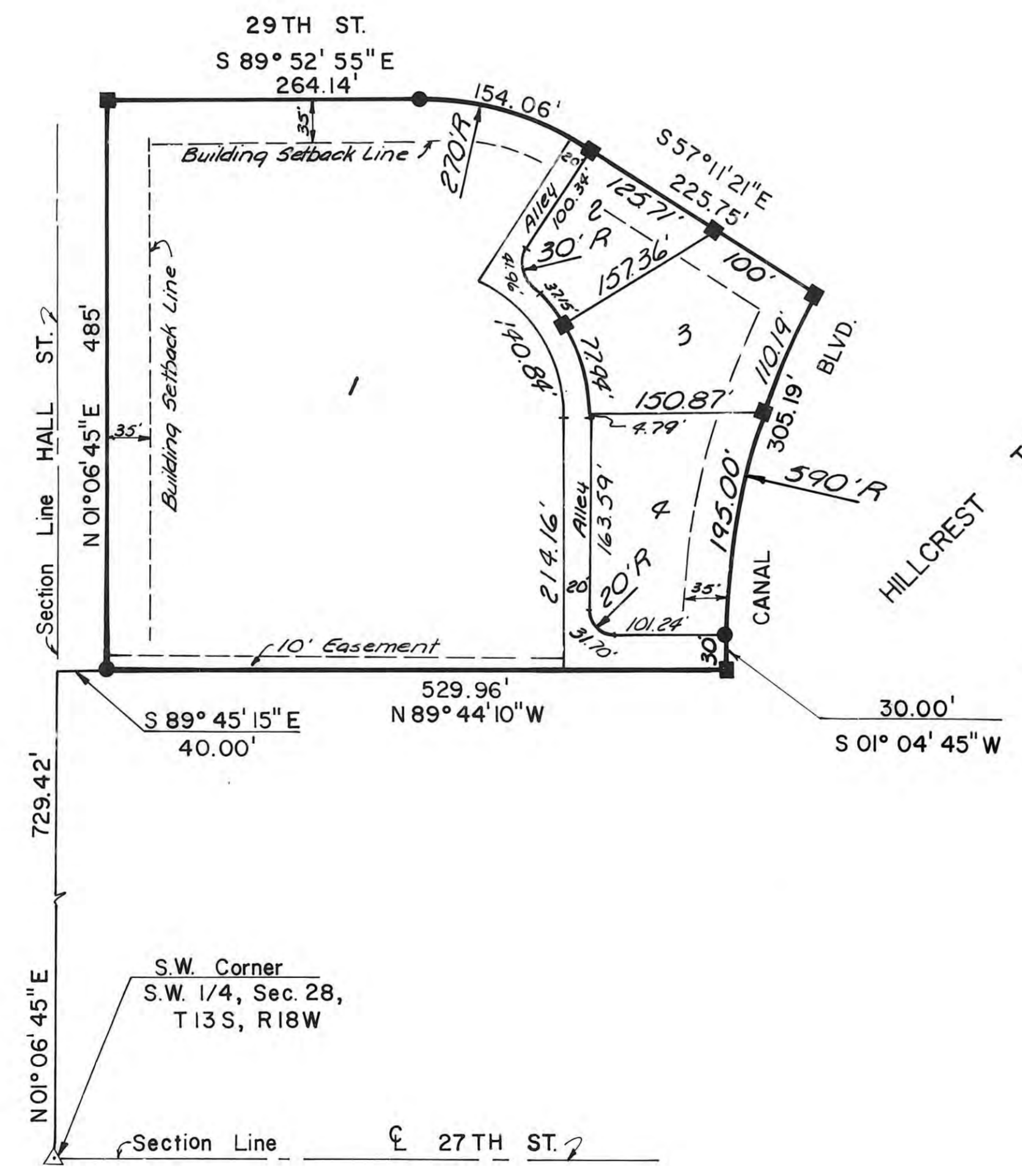
