The Inter-State Addition to Hays City.  
Surveyor's Statement and Certificate.

The Inter State addition to Hays City - Ellis County Kan. as shown and platted herein is bounded and described as follows: The North East Quarter of the South West Quarter and lots 1 and 2 of Section 3 Township 14 South of Range 15 West of the 6<sup>th</sup> Principal meridian. Excepting that area in the North West corner of said South West Quarter sold to Conrad Kuegel and Rutha Kuegel and also area in the South West corner of said tract of land, sold to Chas. Howard and Willie Howard as appears upon the records of the Register of Deeds of Ellis County - Kansas. The initial point of said plat is which all directions are upward in a point three hundred and sixty one and 3/4 feet east of the North West corner of said quarter section. All lots are 60 feet wide including front blocks which is 30 feet wide. Ais at 31 feet and South at 70 ft. All alleys are 15 ft wide. All lots are 30 ft wide by 125 ft in length, excepting such lots and fractional blocks having other dimensions marked thereon. All lots and blocks and fractional blocks are numbered as shown in plat.
