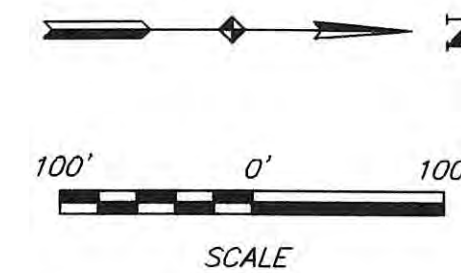


L. KUHN ADDITION

ELLIS COUNTY, KANSAS



LEGAL DESCRIPTION:

A tract of land situated in the Northwest Quarter (NW 1/4) of Section 7, Township 14 South, Range 17 West of the Sixth Principal Meridian, Ellis County, Kansas and described as follows:

Beginning at the Southwest corner of the Northwest Quarter of Section 7, Township 14 South, Range 17 West; Thence on an assumed bearing of North 00 degrees 00 minutes 00 seconds East along the West line of said Section 7 a distance of 1148.71 feet; Thence on a bearing of South 90 degrees 00 minutes 00 seconds East at a distance of 365.00 feet; Thence on a bearing of South 00 degrees 00 minutes 00 seconds West a distance of 1142.62 feet to the South line of the Northwest Quarter of said Section 7; Thence on a bearing of South 88 degrees 53 minutes 15 seconds West along the South line of said Northwest Quarter a distance of 365.07 feet to the Point of Beginning. Said tract contains 9.619 acres.

STREETS & EASEMENTS:

Streets, and drives as shown on this plat and not heretofore dedicated to and for public use are hereby dedicated. Easements are hereby dedicated for public use, as utility easement right-of-way, which are shown as lying between the dashed lines in widths indicated and as set forth on this plat, and said easements may be employed for the purpose of installing, repairing and maintaining gas lines, electric lines, telephone lines, and all other forms and types of public utilities, now or hereafter used, by the public over, under and along the strips marked "Utility Easement"

OWNER'S CERTIFICATE:

Know all men by these presents, that the undersigned property owner of the land above described has caused the same to be surveyed and platted into Lots, Blocks, Streets, Drives and Easements, the same to be known as "L. Kuhn Addition", in Ellis County, Kansas. The Streets and Drives are hereby dedicated to and for the use of the public, and the easements as indicated on the accompanying plat are hereby granted to the public for the purpose of constructing, operating, maintaining, and repairing all public utilities.

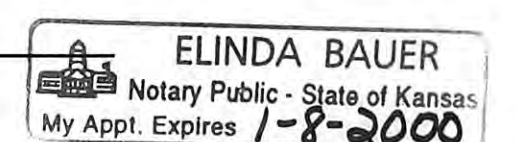

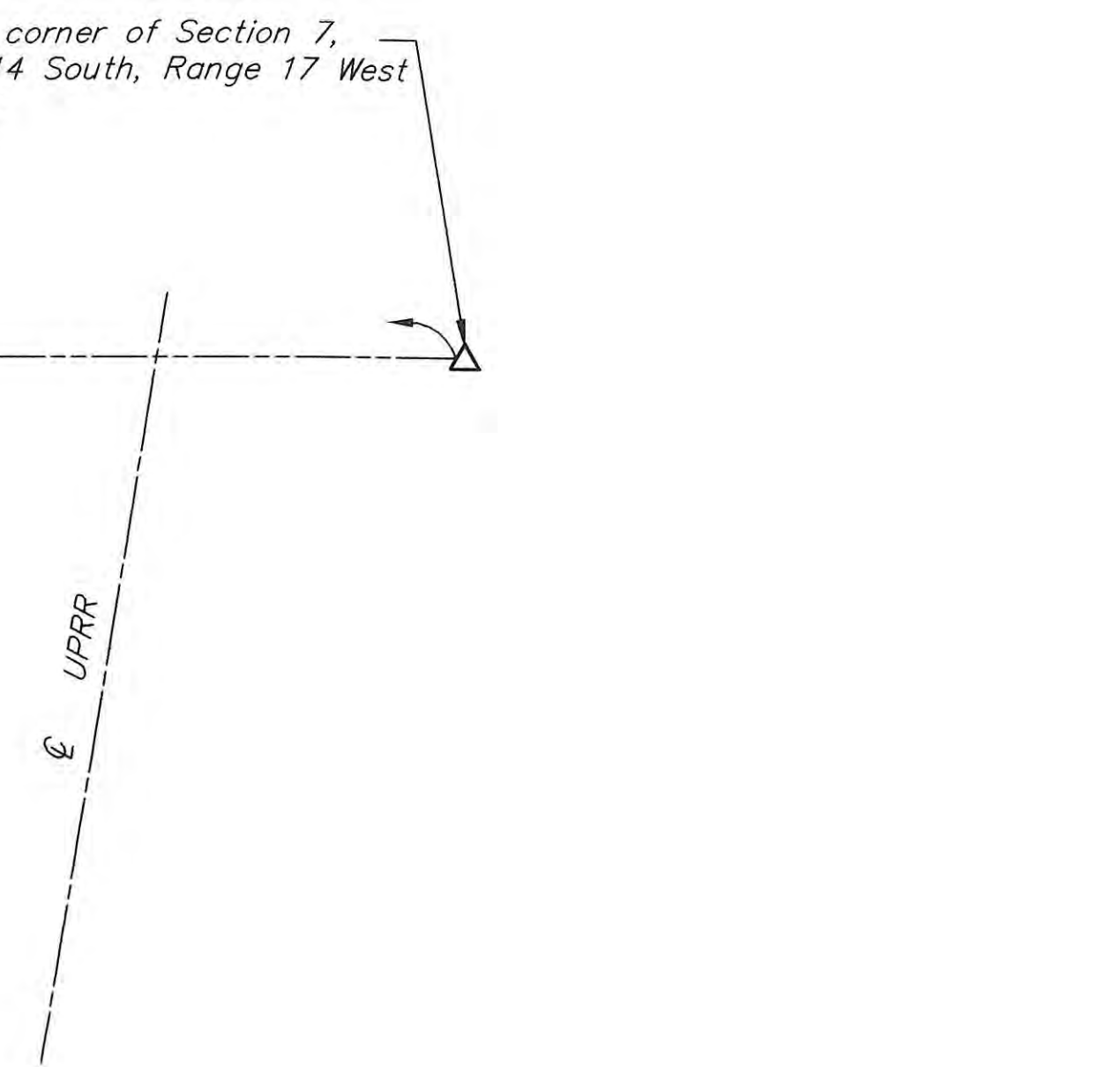

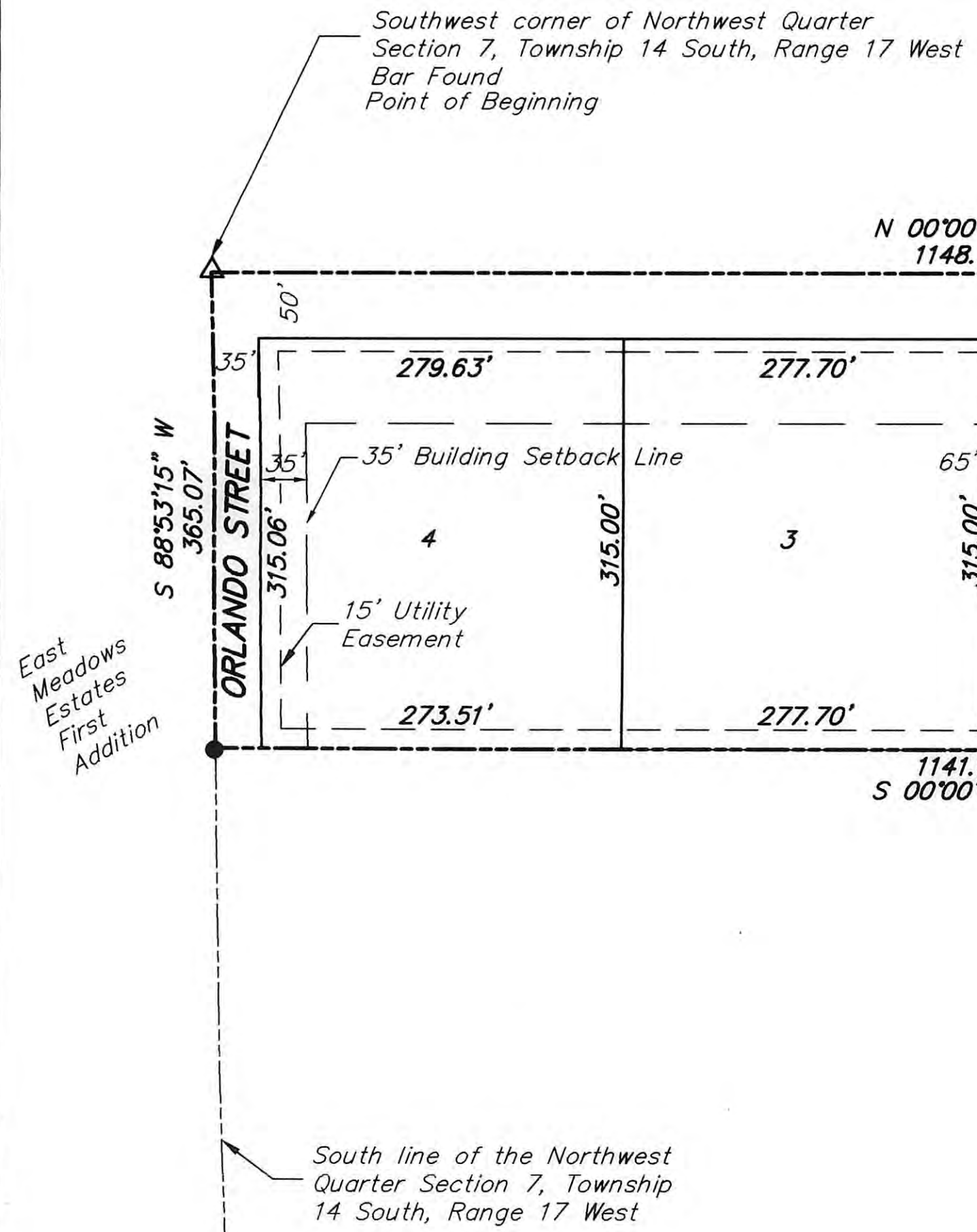
