

DEDICATION.

The undersigned, H.C. and M.R. Raynesford, Owners of the west 177 1/2 feet of the S.E. 1/4 of the S.E. 1/4 of section 5, Twp. 13 S., R. 20 W., in Ellis County, Kansas, have caused said tract of land to be subdivided and platted as an addition to the City of Ellis, Ellis County, Kansas, to be known and designated as "Raynesford's Second Addition". The plat thereof is recorded with this Dedication which is attached thereto. Said addition is a tract 177 1/2 feet wide, east and west, by 1290 feet, north and south, commencing on the north line of Sherman Street in said city and extending north to the north line of the southeast quarter of said section 5. Said addition consists of three half-blocks, numbered "4", "5" and "13", which half-blocks are directly opposite, and a continuation of, the certain half-blocks, bearing the same numbers, on the west side of "Raynesford Bros." addition to Ellis. All streets and alleys and halves of streets and alleys, designated on said plat are hereby dedicated to the public for public use.

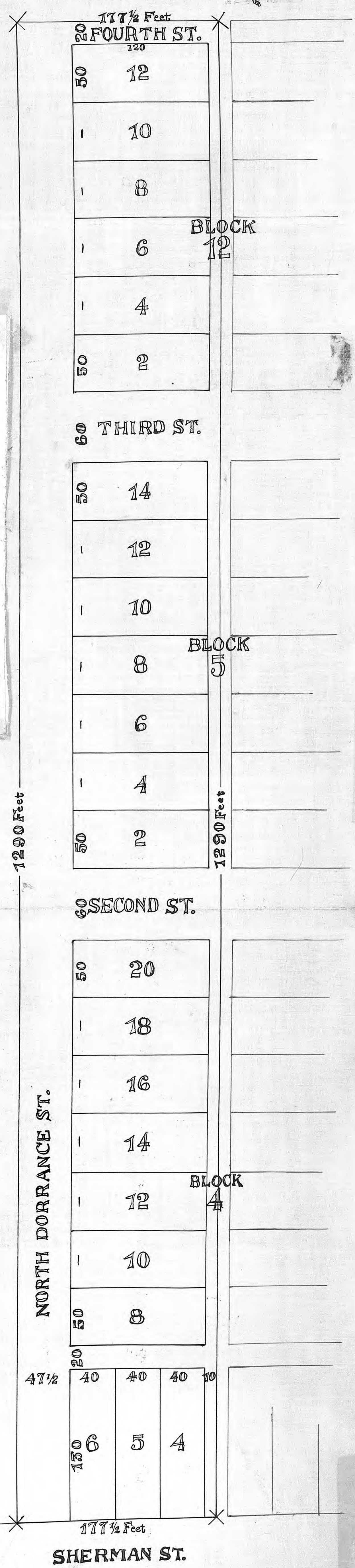
