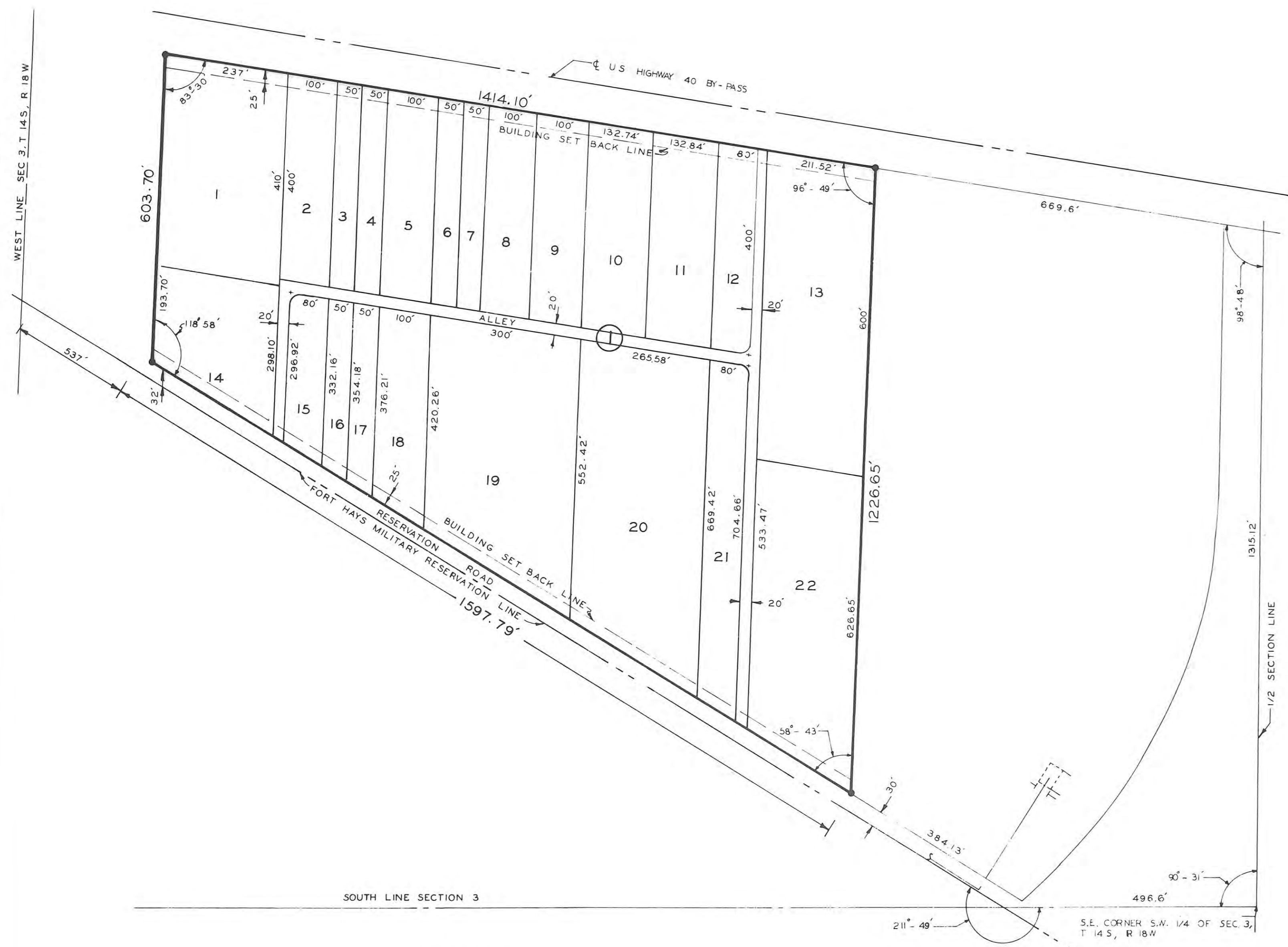

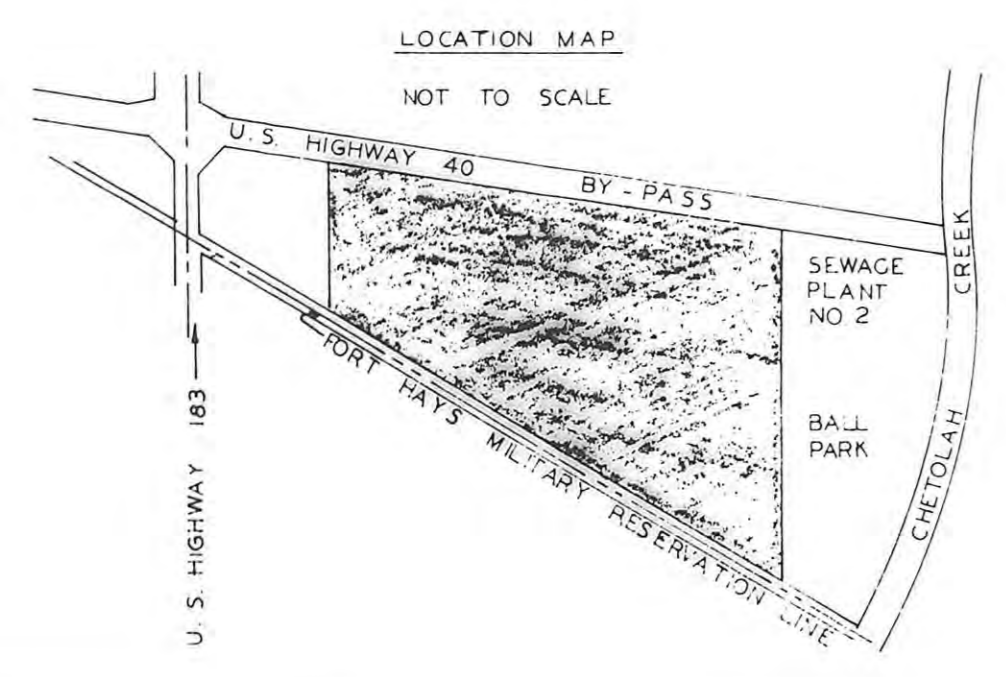
RESERVATION ADDITION

LEGAL DESCRIPTION:
 A tract of land in the Southwest one-quarter (1/4) of Section 3, Township 14 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas, and further described as follows:

Beginning at a point 32 feet North and 537 feet South 56 degrees 54 minutes East, of the intersection of the West line of Section 3, and the North line of the Fort Hays Military Reservation; thence North parallel to the West line of said Section 3, a distance of 603.70 feet to the South Right-of-Way line of the U. S. Highway 40 By-pass; thence Southeasterly along the South Right-of-Way line of U. S. Highway 40 By-pass, a distance of 1,114.10 feet; thence South, parallel to the West line of said Section 3, a distance of 1,226.65 feet, to a point 32 feet North of the Fort Hays Military Reservation Line; thence Northwesterly, parallel to the Fort Hays Military Reservation Line, a distance of 1,597.79 feet to the point of beginning. Tract contains 31.639 acres.

STREETS, ALLEYS, AND EASEMENTS:
 Streets, alleys, and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing and maintaining all public and private utilities now or hereafter.
