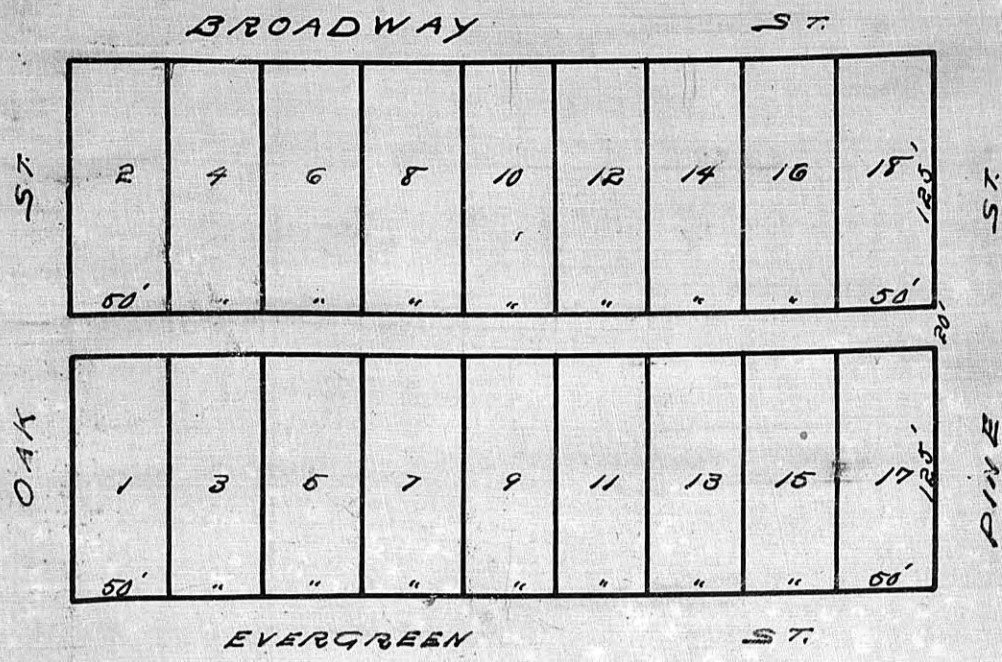


BLOCK 4
