DESCRIPTION

A tract of land in the West Half of the Southeast Quarter of Section 3, Township 14 South, Range 18 West, of the 6th Principal Meridian, Ellis County, Kansas, and described as follows:

Beginning at a point being 249.40 feet East of the Southwest Corner of said Southeast Quarter, and being on the South Line of said Southeast Quarter;

Thence North 174.65 feet;

Thence West 249.40 feet to the West Line of said Southeast Quarter;

Thence North on said West Line 100.85 feet to the easterly line of the City of Hays Chetolah Drainage Ditch;

Thence Northeasterly on the easterly line of said Drainage Ditch on a curve to the left, having radius of 1414.1 feet and central angle of 23° 58' 28", an arc distance of 591.70 feet;

Thence North on the tangent, extended, of said curve 89.22 feet;

Thence East 126.34 feet;

Thence North 318.44 feet to the Southerly Right of Way Line of U.S. Highway 40 Bypass;

Thence South 81° 01' 00" East on said Southerly Right of Way Line 353.76 feet;

Thence South 1202.51 feet to the South Line of said Southeast Quarter;

Thence West on the South Line of said Southeast Quarter 348.36 feet; to the Point of Beginning.

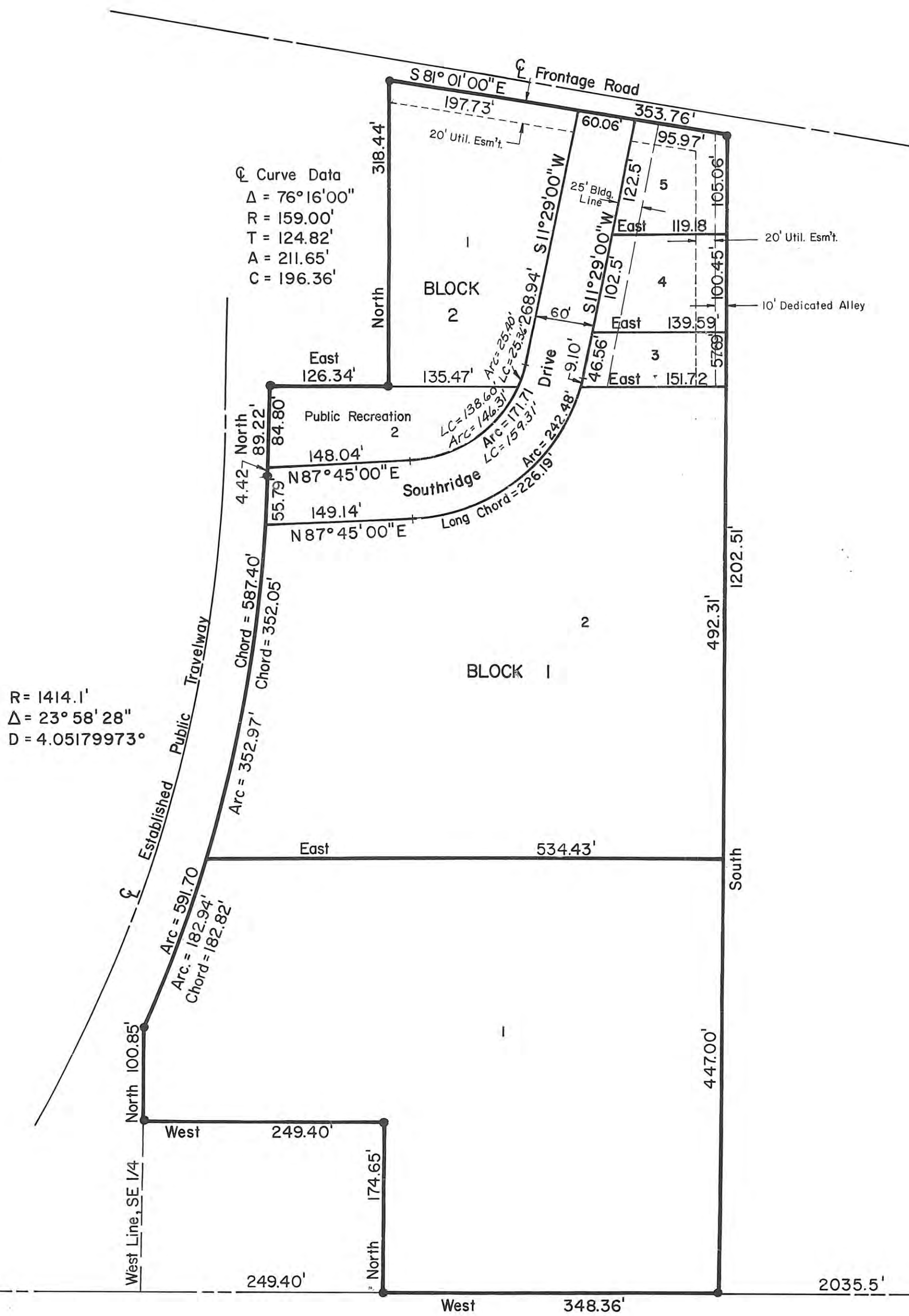
