IMMACULATE HEART OF MARY PARISH ADDITION
 BEING A REPLAT OF BLOCKS 2 AND 4, P.C. DECHANT'S SUB-DIVISION AND
 A PORTION OF LOT 11 AND ALL OF LOTS 13 THROUGH 18, BLOCK 8 FAIRVIEW ADDITION
 HAYS, KANSAS

LEGAL DESCRIPTION: *portion of*

All of Blocks Two (2) and Four (4), P.C. Dechant's Sub-Division of Block Eighty-five (85), in Lebold Allen & Company's Addition to the City of Hays, Kansas and a portion of Lot Eleven (11), and all of Lots Thirteen (13) through Eighteen (18) in Block Eight (8), Fairview Addition to the City of Hays, Kansas. Also that portion of vacated Milner Street between the Northerly line of 18TH Street and the Southerly line of 19TH Street, more particularly described as follows:

Commencing at the Southeast corner of Section Thirty-three (33), Township Thirteen (13) South, Range Eighteen (18) West of the Sixth Principal Meridian, Ellis County, Kansas; Thence on a grid bearing of North 01 degrees 10 minutes 48 seconds East along the East line of said Section 33 a distance of 1212.83 feet; Thence on a bearing of North 88 degrees 49 minutes 12 seconds West a distance of 50.00 feet to the West right of way line of Vine Street (U.S. Highway 183) and the Point of Beginning; Thence on a bearing of South 60 degrees 07 minutes 51 seconds West along the West right of way line of Vine Street a distance of 16.17 feet to the Northerly right of way line of 18th Street; Thence on a bearing of North 61 degrees 32 minutes 39 seconds West along the Northerly right of way line of 18th Street a distance of 686.43 feet to the center line of vacated Milner Street; Thence on a bearing of North 61 degrees 30 minutes 11 seconds West along the extension of the Southerly line line of Block 8, Fairview Addition to the City of Hays, Kansas a distance of 180.02 feet to the Easterly line of Lot 11, Block 8 of said Fairview Addition; Thence on a bearing of North 29 degrees 17 minutes 23 seconds East along the Easterly line of said Lot 11 a distance of 107.09 feet to a point 20 feet from the Northeast corner of said Lot 11; Thence on a bearing of North 16 degrees 21 minutes 29 seconds West a distance of 27.96 feet to the Northerly line of said Lot 11; Thence on a bearing of South 62 degrees 00 minutes 20 seconds East along the Northerly line of said Lot 11 a distance of 20.00 feet to the Northeast corner of said Lot 11; Thence on a bearing of North 29 degrees 17 minutes 23 seconds East along the extension the Westerly line of Lot 14, Block 8 of said Fairview Addition a distance of 147.10 feet to the Southerly line of 19th Street; Thence on a bearing of South 62 degrees 30 minutes 27 seconds East along the Southerly line of 19th Street a distance of 180.09 feet to the center line of said Milner Street; Thence on a bearing of South 62 degrees 02 minutes 11 seconds East along the extension of the Northerly line of Blocks 2 and 4 of said P.C. Dechant's Sub-Division a distance of 552.57 feet to the West right of way line of said Vine Street; Thence on a bearing of South 01 degrees 10 minutes 48 seconds West along said West line of Vine Street a distance of 301.86 feet to the Point of Beginning. Said parcel contains 5.17 acres.

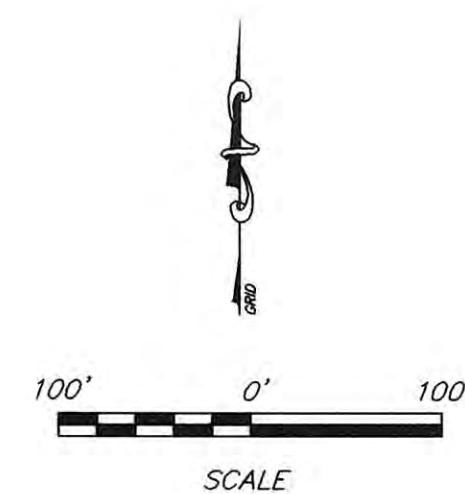
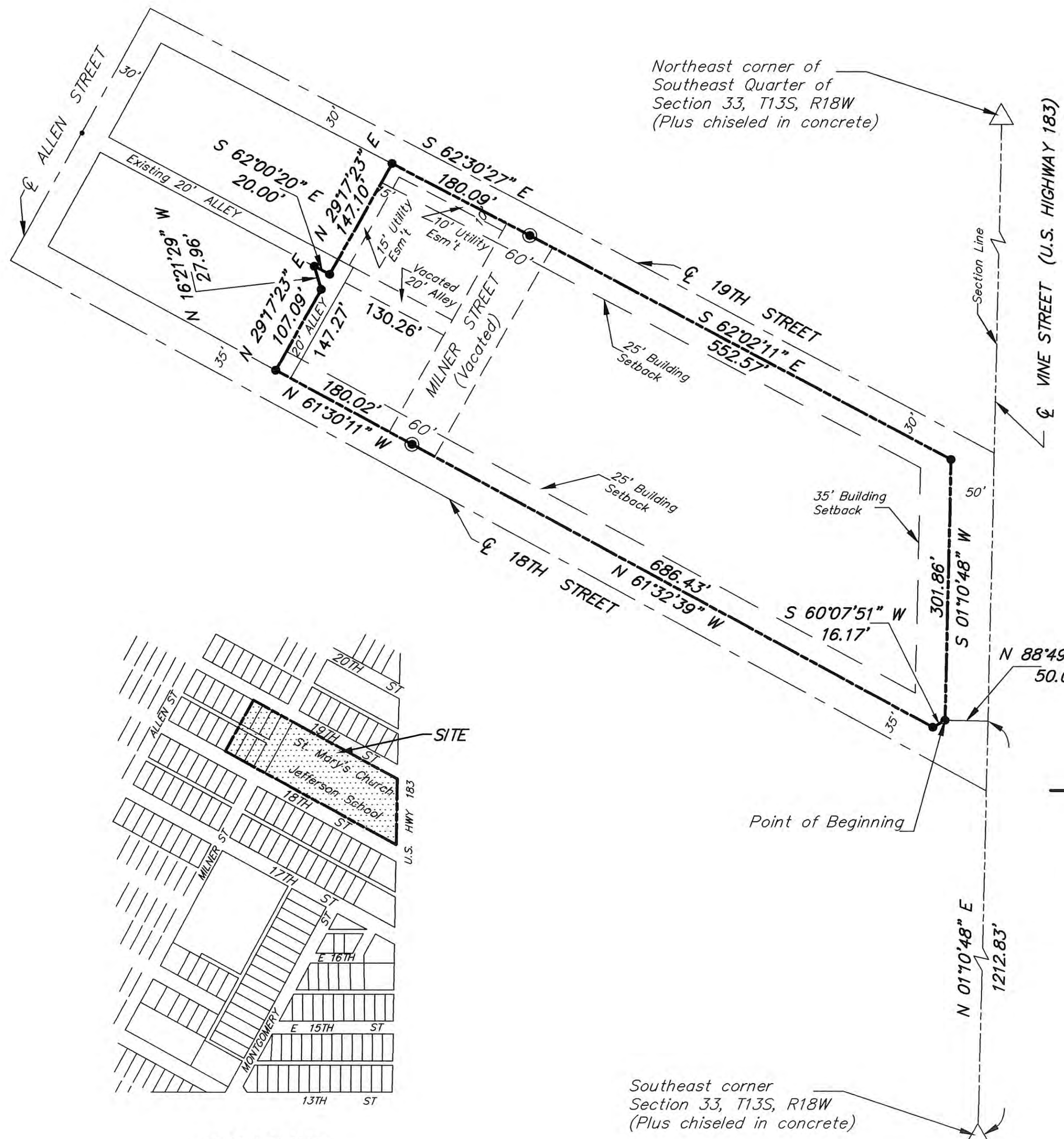

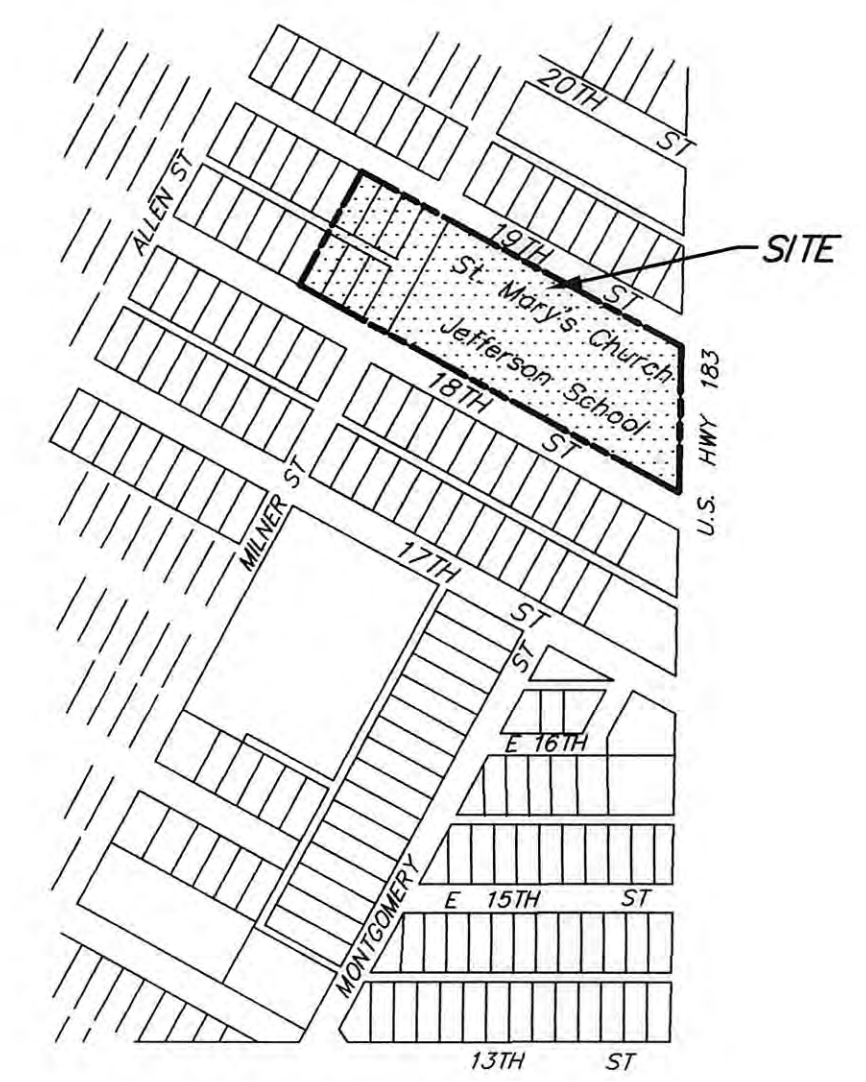
