

# REPLAT OF BLOCK 14 & LOTS 4 THRU 23 OF BLOCK 16 SUNRISE ADDITION HAYS, KANSAS

**LEGAL DESCRIPTION:**  
A tract of land in the Southeast Quarter of Section 34, Township 13 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas, more particularly described as follows:  
  
Beginning at the Northeast Corner of the Southeast Quarter of said Section 34; thence on an assumed bearing of S 0°24'26" W along the East line of said Southeast Quarter, a distance of 1786.52 feet; thence due West, a distance of 311.74 feet; thence in a Northwesterly direction on a curve to the left having a radius of 300.00 feet, the initial tangent of which has a bearing of N 14°16'42" W, an arc distance of 119.18 feet; thence tangent to said curve N 37°02'24" W, a distance of 61.71 feet; thence N 52°57'36" E, a distance of 30.00 feet; thence in a Northerly direction on a curve to the left having a radius of 100.00 feet, an arc distance of 92.43 feet; thence tangent to said curve due North, a distance of 265.03 feet; thence in a Northwesterly direction on a curve to the left having a radius of 300.00 feet, an arc distance of 193.94 feet; thence tangent to said curve N 37°02'24" W, a distance of 319.17 feet; thence N53°14'45" E, a distance of 166.25 feet; thence in a Northerly direction on a curve to the left having a radius of 300.00 feet, an arc distance of 277.09 feet; thence tangent to said curve N 0°19'35" E, a distance of 493.63 feet; thence N 89°56'52" E, a distance of 345.49 feet to the point of beginning.

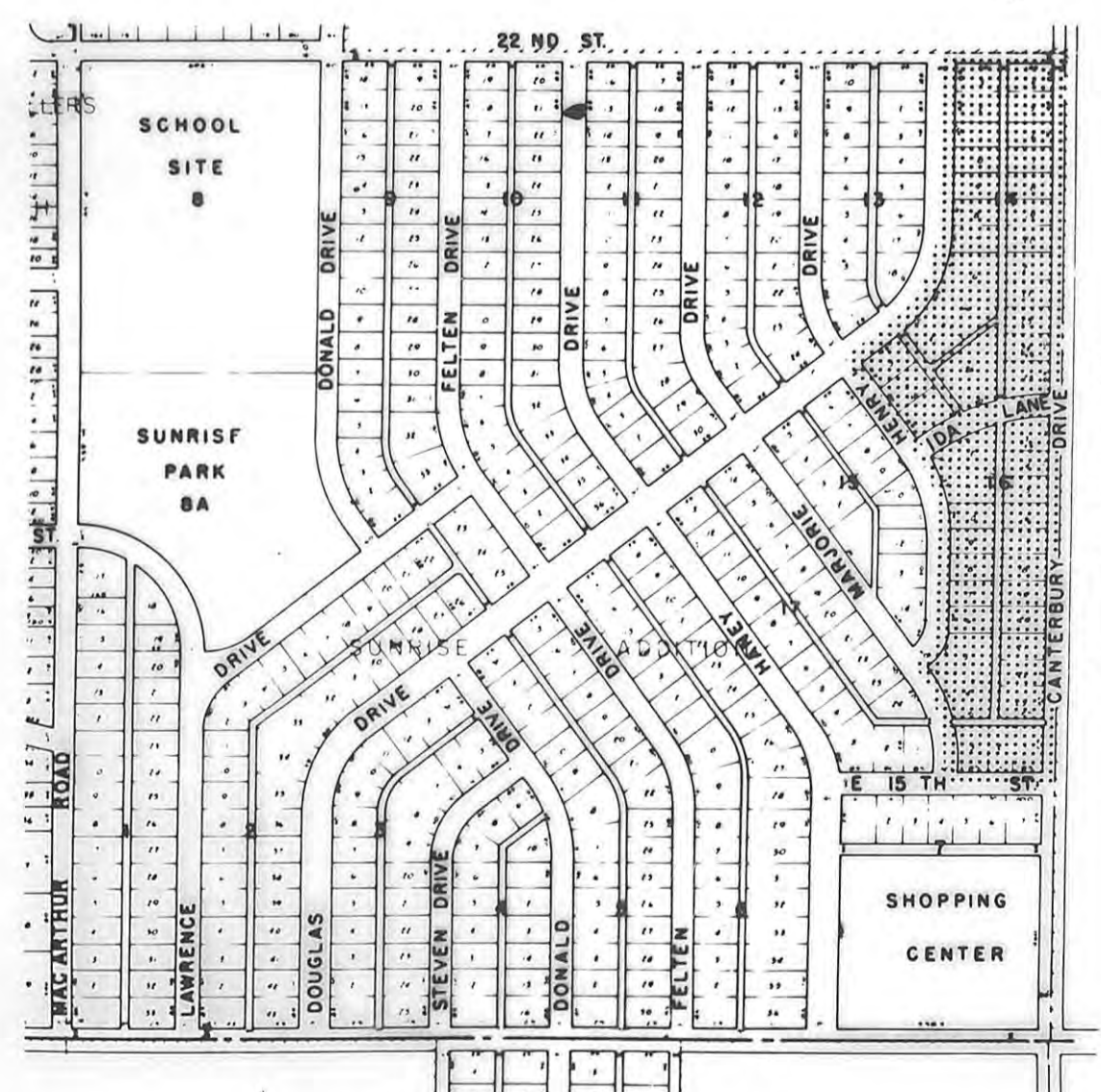

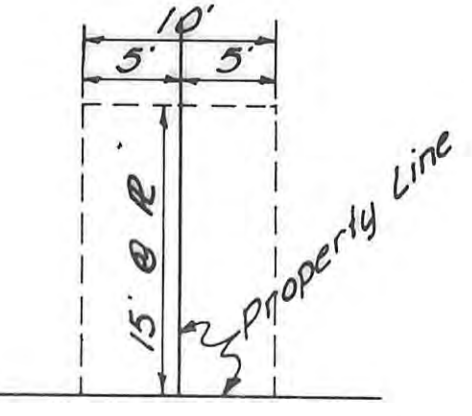
