A tract of land in the SW¹/₄ of Section 34, Township 13, Range 18, West of the 6th P. M. described as follows: Beginning at a point 1880 feet east of the Southwest Corner of Section 34, thence North 1083 feet parallel with the west Section line of said section 34; thence east 660 feet parallel with south section line of section 34, to intersect north and south center line; thence south 1083 feet; thence west 660 feet to place of beginning, containing 16 acres more or less, according to U. S. Government Survey thereof.

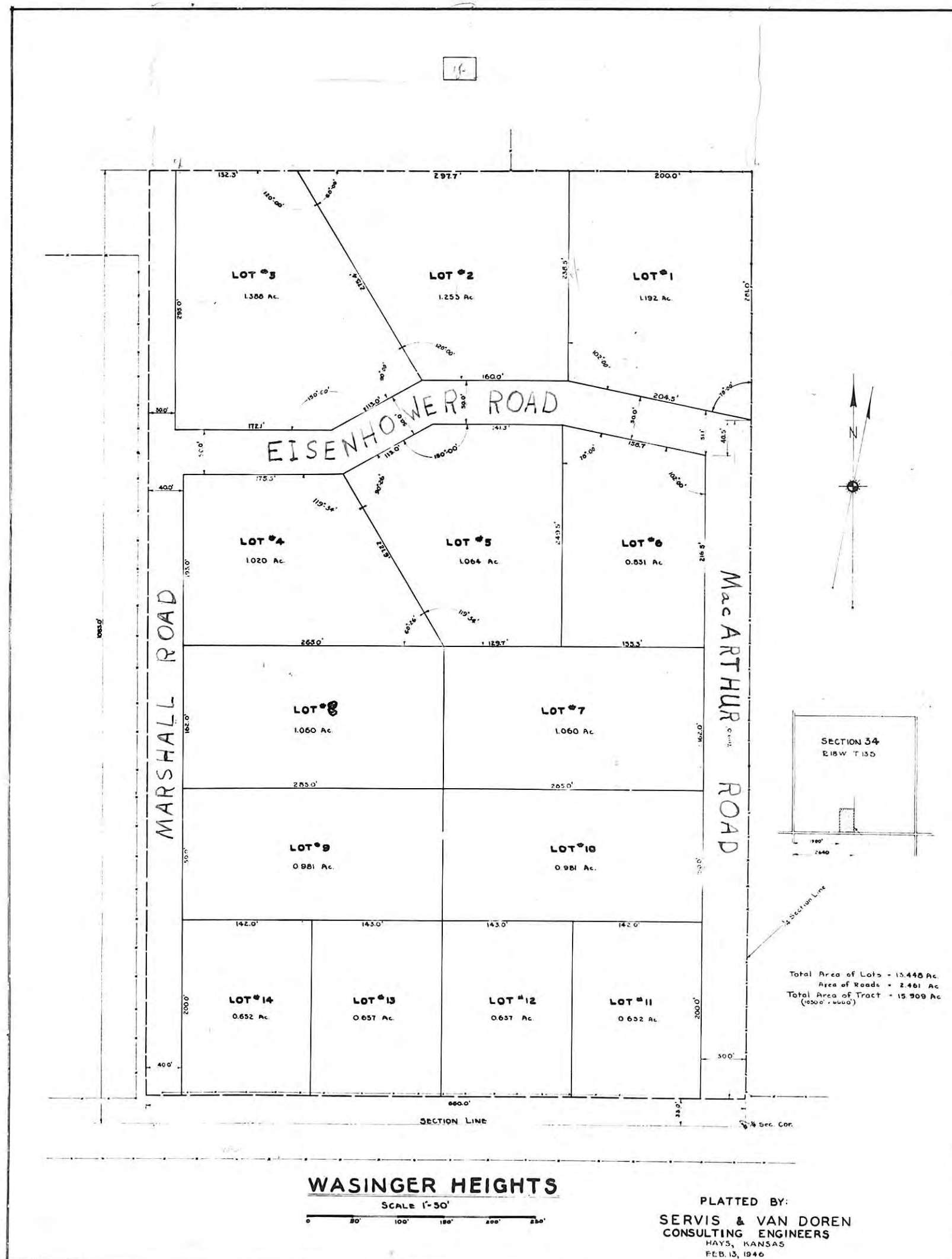
