LEGAL DESCRIPTION:

A tract of land in the Southeast one-quarter of Section 34, Township 13 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas and further described as follows:

Beginning at the Northeast corner of the intersection of East Fifteenth (15th) Street and Dechant Road in the City of Hays, Kansas; thence North, along the East line of Dechant Road, two hundred sixty-five and forty hundredths (265.40) feet to the South line of East Seventeenth (17th) Street; thence East along the South line of East Seventeenth (17th) Street, two hundred seventy-three and thirty-two hundredths (273.32) feet; thence South, to a point on the North line of East Fifteenth (15th) Street, said point being two hundred seventy-two and fifteen hundredths (272.15) feet East of the point of beginning; thence West, along the North line of East Fifteenth (15th) Street to the point of beginning.

OWNER'S CERTIFICATE:

This is to certify that the undersigned is the owner of the land described in the plat, and that he has caused the same to be surveyed and subdivided as indicated thereon, for the uses and purposes therein set forth, and does hereby acknowledge and adopt the same under the style and title thereon indicated.

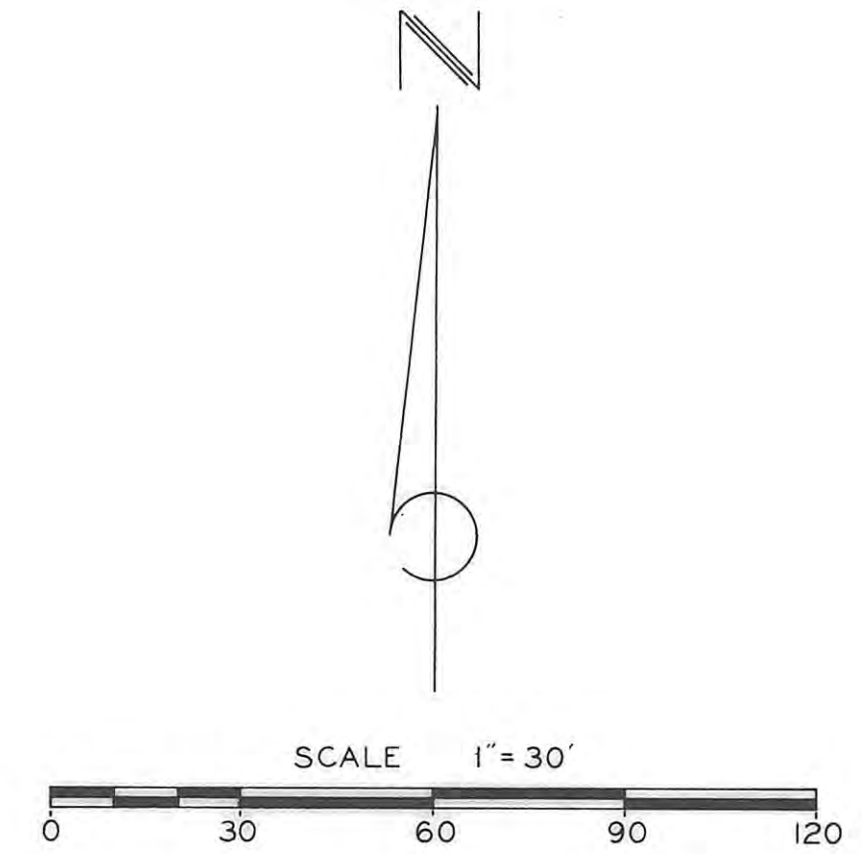
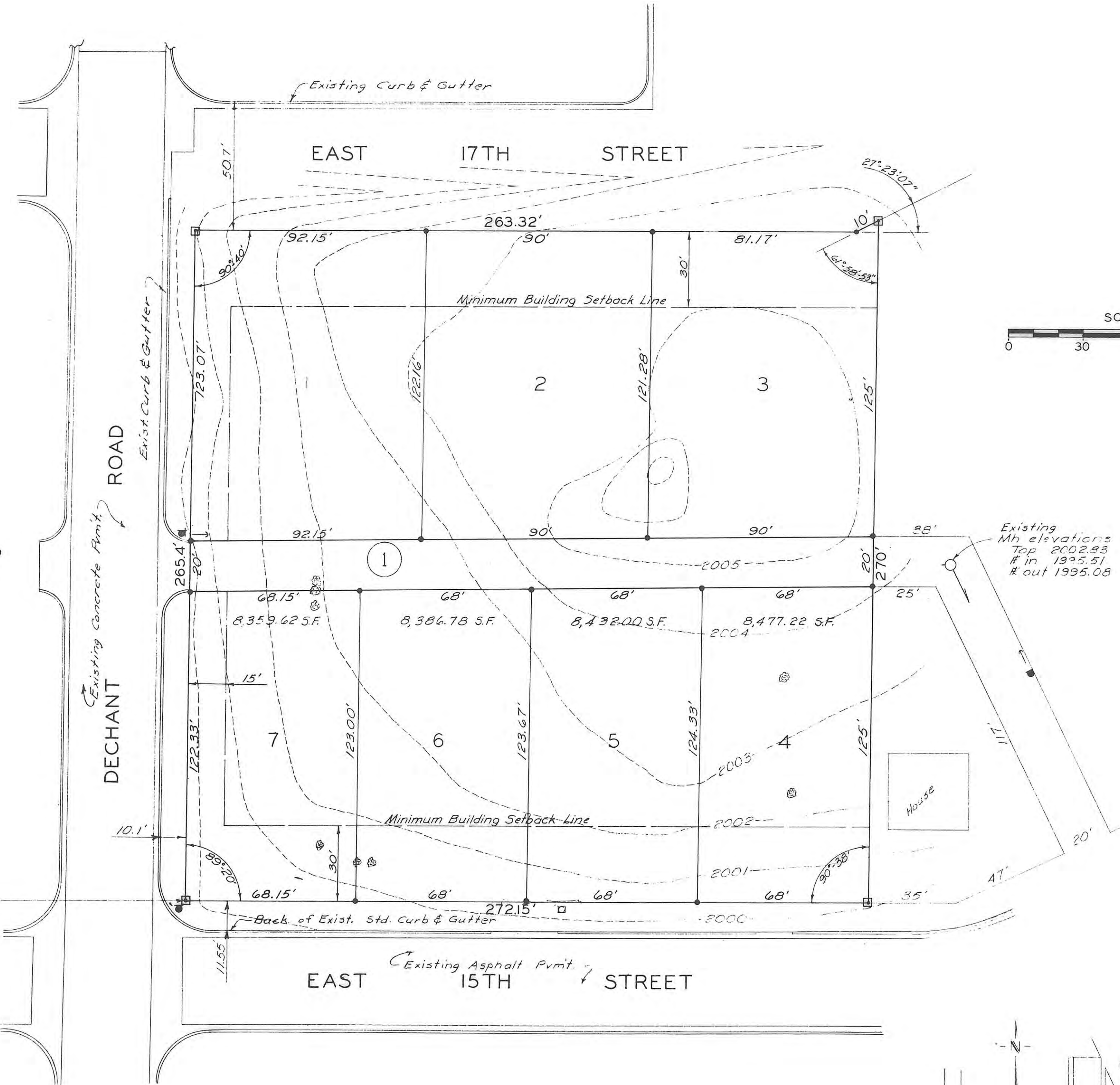

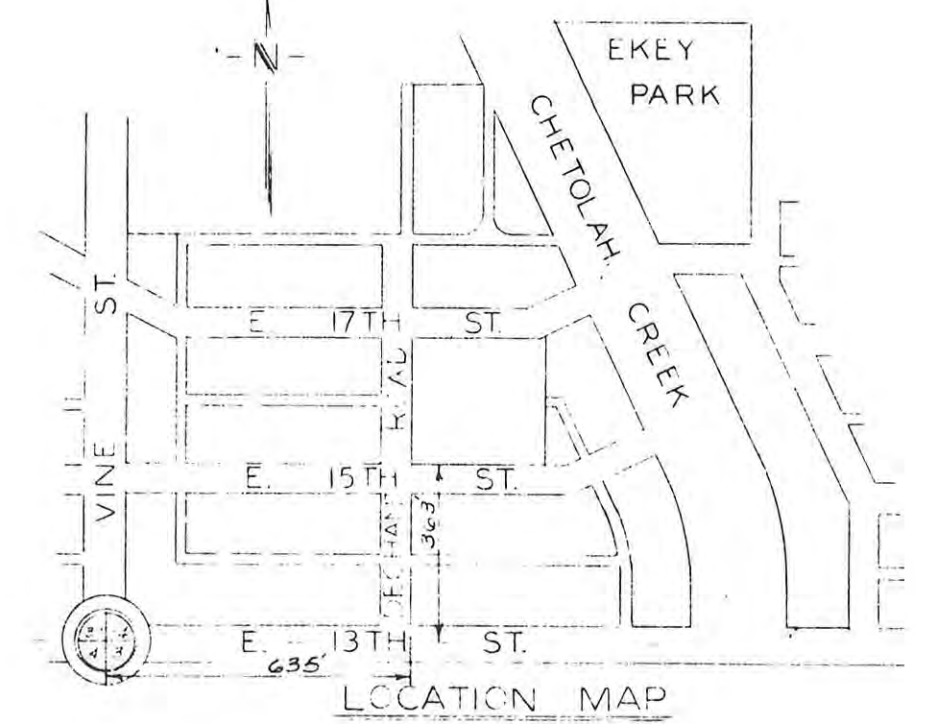
